Whereas, pursuant to the recommendation of the Leh Autonomous Hill Development-Subordinate Service Recruitment Board (LAHD-SSRB) (12) candidates was provisionally selected as **Panchayat Accounts Assistant**, in Rural Development Department of the Administration of Union territory of Ladakh, in **Level-5 of pay matrix (Rs.29,200-92,300).**

Whereas, Rural Development Department, UT Ladakh vide Memorandum No: **M/1967/2023-RD&PR SECTION-Part (1)/221-227**, dated:29.07.2026, issued an offer of appointment to the candidates selected provisionally for the post of **Panchayat Accounts Assistant** with directions to submit the acceptance undertaking within 15 days from the issuance of the said memorandum.

Whereas, in terms of instructions contained at para (14) in the Memorandum issued by the office of the Administrative Secretary, Rural Development, UT Ladakh, the candidates who fail to submit the undertaking within a period of 15 days from the date of issuance of memorandum shall result in the cancellation of the offer of appointment.

Whereas, the Director, Rural Development Department, UT Ladakh, vide letter No.DRD/UTL/E-101/LAHD-SSRB/2026/5950-54, dated:17.08.2026, intimated that the candidates mentioned at Annexure I has submitted undertaking expressing unwillingness to accept the post.

Now therefore, in light of the above, the offer of appointment issued in favour of (11) candidates mentioned below for the post of Panchayat Accounts Assistant in Rural Development Department, UT Ladakh, is deemed to have been cancelled w.e.f. 13.08.2026.
