 - On the basis of her performance or conduct, she is considered unsuitable for further retention in service, or
 - She is otherwise found ineligible or unsuitable to be retained in the service.
- The above appointee has been declared medically fit by the Prescribed Medical Authority.
- This appointment is subject to the verification of character and antecedents; verification of the certificate of reserved category; and verification of certificates/marksheets relating to the educational qualification and such essential requirement as prescribed in the Union territory of Ladakh Rural Development Department (Subordinate) Service Recruitment Rules, 2021.

It is further ordered that:

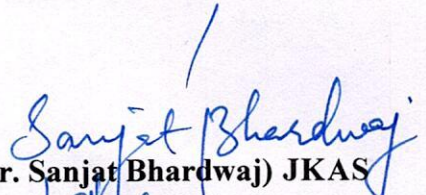
