 - a) On the basis of his / her performance or conduct, he / she is considered unsuitable for further retention in service, or
 - b) He / she is otherwise found ineligible or unsuitable to be retained in the service.
3. The above appointees have been declared 'medically fit' by the Prescribed Medical Authority.
4. The appointees shall have to undergo Accounts Clerk Course (A.C.C) Training or any other Training as may be prescribed/notified by the Finance Department and to qualify ACC Examination

or any other Examination during the period of probation as may be prescribed/notified by the Finance Department, as prescribed under the **Recruitment Rules notified vide S.O. 66 dated 10.12.2021.**

5. This appointment is subject to the verification of character and antecedents; verification of the certificates of reserved category and verification of certificates / mark-sheets relating to the educational qualification and such essential requirements as prescribed in the Ladakh Accounts (Subordinate) Services Recruitment Rule, 2021.

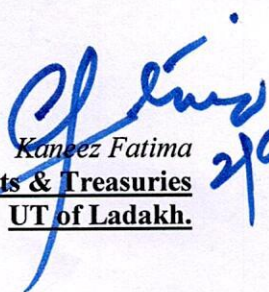
