Whereas, vide above referred notification dated 28.07.2026, the Ladakh Subordinate Services Staff Selection Board (LSSSSB) issued the selection list of 58 candidates against the post of Accounts Assistant [Group 'C', Non-Technical in the Pay Matrix of Level-5 (29200-92300)] in the Finance Department, Administration of Union Territory of Ladakh.

Whereas, the Finance Department, vide Memorandum F.No-A/1109/2023/(E17085)/1594-98 dated 03.08.2026, issued "Offer of Appointment" to the 58 provisionally selected candidates, granting them 15 days for acceptance, which ended on 18.08.2026.

Whereas, out of the 58 provisionally selected candidates, only 38 (thirty-eight) candidates accepted the Offer of Appointment, while the remaining 20 (twenty) candidates did not accept the Offer of Appointment and have submitted undertakings declining the same.

Therefore, in view of the above, the "Offer of Appointment" to the post of Accounts Assistant in respect of the said 20 candidates listed in Annexure 'A' to this order is hereby cancelled.

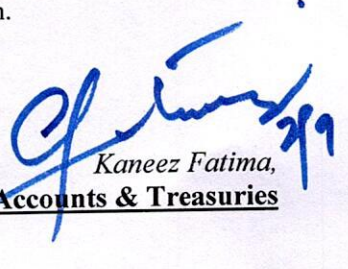

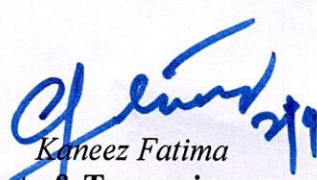
