**Order No.24 -Trans (UTL) of 2026,
Dated: 04.09.2026.**

Whereas, vide Order No. 18-Trans (UTL) of 2026 dated 05.08.2026, tentative seniority list of Non-Gazette employees in Motor Vehicle Department, UT of Ladakh was issued/notified for information and inviting objections, if any, from the stakeholders with respect to the seniority assigned to them, the date of birth, and entries relating to the post of Motor Vehicle Inspector/Junior Assistant/Orderly and names recorded in the relevant columns in the seniority list; and

Whereas, one representation was received from Sh. Shabir Hussain, Class IV employee, regarding exclusion of his name in the tentative seniority list. The official in his representation stated that he was appointed as Class IV through the erstwhile District Services Selection Recruitment Board (DSSRB), Kargil in the year 2010, initially posted/appointed in the Medical Department, Kargil and was transferred to the office of ARTO, Kargil in the year 2015 by Order of the then Deputy Commissioner, Kargil and thereafter, he is continuously working in the Transport Department in the office of ARTO, Kargil. The official further stated that his name has not been included in the seniority list of the non-gazetted employees of Motor Vehicle Department by the Transport Department till date. It has been further stated that the issue concerning seniority in the Transport Department is also the subject matter of litigation before the Hon'ble Central Administrative Tribunal, Srinagar bench, in OA No. 628/2022 titled "Shabir Hussain v/ UT of Ladakh & Others" and the proceedings/order is presently sub-judice before the Hon'ble High Court of Jammu & Kashmir and Ladakh. The said official requested for inclusion of his name in the seniority list of Transport Department; and

Whereas, upon examination of the representation submitted by Sh. Shabbir Hussain, Class IV employee, it has been found that General Administration Department, UT of Ladakh, vide communication F. No. A-12/48/2024-GAD SEC dated 10.02.2026, has instructed the Deputy Commissioners/CEO, LAHDCs of Leh and Kargil districts regarding review of irregular promotion/absorption and prohibition on change of department/cadre, wherein reference has been invited towards the clear and unambiguous instructions prohibiting change of cadre issued vide Circular No. 07-GAD of 2003 dated: 12.03.2003 and Circular No. 25-GAD of 2003 dated: 29.08.2003 by the GAD of erstwhile state of J&K. These circular instructions categorically advised all concerned authorities not to recommend or process cases involving change of department/cadre, as the same was not permissible under the Recruitment Rules. In view of these instructions of the GAD, the

representation of Sh. Shabbir Hussain, Class IV employee cannot be considered at this juncture and is disposed of accordingly.

Now, therefore, the final seniority list of Non-Gazetted employees in Motor Vehicle Department, UT of Ladakh, as it stood on 04.09.2026, forming "Annexure A", "Annexure B" and "Annexure C" to this Order, is hereby issued/notified. The date of birth recorded in the seniority list shall be subject to further verification from the service book and matriculation certificate of the concerned officials.

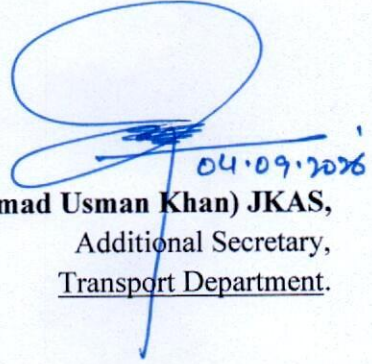
