Whereas, pursuant to the recommendation of the LAHDC-KSSRB, (1) candidate was provisionally selected as Junior Assistant, in Rural Development Department of the Administration of Union territory of Ladakh, in Level-4 of Pay Matrix. (Rs.25,500-81,100).

Whereas, Rural Development Department, UT Ladakh vide Memorandum No.M/1967/2023-RD&PR Section/262-68, dated: 03.08.2026, issued an offer of appointment to the candidate selected provisionally for the post of Junior Assistant with directions to submit the acceptance undertaking within 15 days from the issuance of the said memorandum.

Whereas, in terms of instructions contained at para (14) in the Memorandum issued by the office of the Administrative Secretary, Rural Development, UT Ladakh, the candidate who fail to submit the undertaking within a period of 15 days from the date of issuance of memorandum shall result in the cancellation of the offer of appointment.

Whereas, the Director, Rural Development Department, UT Ladakh, vide letter No.DRD/UTL/E-102/Junior Assistant/2026/ dated:08.2026, intimated that the candidate mentioned at Annexure I has submitted undertaking expressing his unwillingness to accept the post.

Now therefore, in light of the above, the offer of appointment issued in favour of (1) candidate mentioned below for the post of Junior Assistant in Rural Development Department, UT Ladakh, is deemed to have been cancelled w.e.f. 19.08.2026.

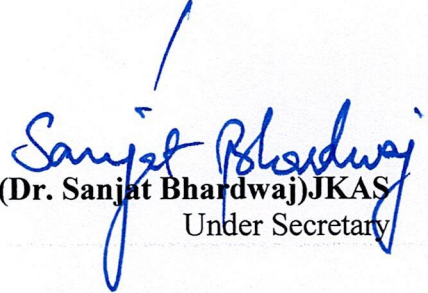
