The appointment shall be subject to the following conditions:

1. The above appointees shall be on probation for a period of two years with effect from the date of their joining. During the period of probation, the appointee(s) will be liable to be discharged from service at any time without any notice, if:
 - i. On the basis of his/ her performance or conduct, he/ she is considered unsuitable for further retention in service, or
 - ii. He / she is otherwise found ineligible or unsuitable to be retained in the service.
2. The above appointee has been declared medically fit by the Prescribed Medical Authority.
3. This appointment is subject to the verification of character and antecedents; verification of the certificates of reserved category; and verification of certificates / mark-sheets relating to the educational qualification and such essential requirements as prescribed in the Ladakh

Agriculture (Subordinate) Service Recruitment Rules, 2022 and must possess the requisite qualification on the cut-off date of notification. All the documents for validity and genuineness shall be verified by the Joint Director, Agriculture Department. If at any stage, it is found that the documents submitted by the appointee are found not valid/genuine, his/her appointment shall be terminated ab-initio.

It is further ordered that;

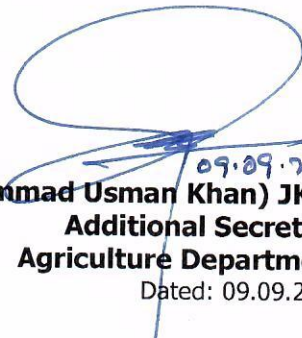
