Consequent upon the reorganization of the administrative districts in the Union Territory of Ladakh and creation of five new districts *vide* Notification S.O. 180 dated 27.04.2026, it has become necessary to align the territorial jurisdiction of the field officers of the Tourism Department with the re-organised administrative boundaries.

Accordingly, and without prejudice to any specific statutory or notified jurisdiction vested in any authority, the territorial jurisdiction of the field officers of the Tourism Department for administrative supervision and discharge of departmental functions shall, with immediate effect and until further orders, be as specified below:

The officers concerned shall accordingly exercise their functions within the territorial jurisdiction assigned to them and shall coordinate with the concerned District Administration and other line Departments for matters falling within their respective jurisdictions.
