The appointment shall be subject to the following conditions, that:

- The appointees shall be on probation for a period of two years with effect from the date of his / her joining the post. During the period of probation, the appointees will be liable to be discharged from service at any time without any notice, if:
 - On the basis of his / her performance or conduct, he / she is considered unsuitable for further retention in service, or
 - He / She is otherwise found ineligible or unsuitable to be retained in the service.
- The above appointees have been declared medically fit by the Prescribed Medical Authority.
- This appointment is subject to the verification of character and antecedents; verification of the certificates of reserved category; and verification of certificates / marksheets

relating to the educational qualification and such essential requirements as prescribed in the Union Territory of Ladakh Youth Services & Sports (Subordinate) Service Recruitment Rules, 2022.

It is further ordered that;

1. The services of the above candidates appointed as Junior Assistant are placed at the disposal of the District Youth Services & Sports Officer, Leh, Youth Services & Sports Department for further deployment in the Sub-Ordinate Offices / Divisions of the Youth Services & Sports Department in Union Territory of Ladakh.
2. The appointees shall report to the Office of the District Youth Services & Sports Officer, Leh, for joining within a period of one (01) month, from the date of issuance of this Order, failing which his/her appointment shall be deemed to have been cancelled ab-initio.
3. The expenditure towards his / her pay and allowances shall be debited against the head of "Salaries" from the Budget Head associated with their respective places of posting upon their deployment in the Sub- Ordinate Offices / Divisions of the Youth Services & Sports, Department.

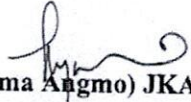
