Whereas, the Directorate Office, vide letter No. JDYSS-UTL / Vac/2026-27/945-46 dated: 19.08.2026, intimated that amongst (05) selected candidates, (02) candidates have submitted acceptance undertaking within the stipulated time i.e. by 17.08.2026, whereas (03) candidates mentioned at **Annexure 1** have not submitted undertakings within the stipulated time.

Now therefore, in light of the above, the offer of appointment issued in favour of the (03) candidates mentioned below for the post of **Junior Assistant** in Youth Services & Sports Department, UT Ladakh, is deemed to have been cancelled w.e.f. 18.08.2026.
