3. *This appointment is subject to the verification of character and antecedents; verification of the certificates of reserved category; and verification of certificates / marksheets relating to the educational qualification and such essential requirements as prescribed in the Ladakh Public Works (R&B) Subordinate Service Recruitment Rules, 2021.*

It is further ordered that;

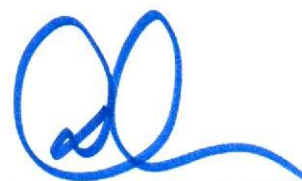
