Whereas, vide the above-referred notification dated 18.07.2026, the Leh Autonomous Hill Development- Subordinate Services Recruitment Board (LAHDC-KSSRB) has issued a selection list of candidates selected against the post of 'Junior Assistant/Tehvildar/Cashier' (Group 'C' Non-Gazetted in Health and Medical Education Department of the Administration of Union territory of Ladakh under district cadre Leh, in Pay Level-4 of structure (Rs. 25,500-81,100).
