Subject: Cancellation of Appointment Order in respect of Mr. Mohd Jawad for the post of Orderly in the General Administration Department, UT of Ladakh, under UT Cadre, in Pay Level-SL 1 of the Pay Matrix, structure (₹ 14800-47100).

Whereas, the Ladakh Subordinate Services Staff Selection Board (LSSSSB), vide the above-referred Notice No. 19 dated 12.02.2026, issued the final Select List for the post of "Orderly/Process Server/Class IV" under Post Code LSB2517 and recommended, inter alia, the name of *Mr. Mohd Jawad* S/o Sh. Ghulam Mehdi, R/o Kaskarik Choskore, Kargil District, for appointment to the post of Orderly in Pay Level-SL 1 of the Pay Matrix (₹14,800–47,100);

Whereas, pursuant thereto, GAD, vide File No. A-12/17/2024-GAD SEC dated 13.02.2026, issued an Offer of Appointment inter alia in favour of *Mr. Mohd Jawad*, whose name figured at S. No. 16 therein, for appointment to the post of Orderly in Pay Level-SL 1 of the Pay Matrix, Structure (₹14,800–47,100), stipulating therein a period of thirty (30) days for acceptance of the said offer, which was duly accepted by *Mr. Mohd Jawad* on 14.02.2026;

Whereas, consequent upon such acceptance, an Appointment Order was issued inter alia in favour of *Mr. Mohd Jawad* vide Order No. 142-LA (GAD) of 2026 dated 19.03.2026, stipulating therein that he was required to join the post within a period of one (01) month from the date of issuance of the said Appointment Order;

Whereas, on 16.04.2026, *Mr. Mohd Jawad* approached GAD with a representation seeking extension of the time limit for joining the post of Orderly;

Whereas, upon consideration of his representation and in light of the DoPT OM issued vide File No. 35015/2/93-Estt.(D) dated 09.08.1995, the joining time of *Mr. Mohd Jawad* was extended by two months w.e.f. the date of issuance of Order No. 203-LA (GAD) of 2026 dated 17.04.2026;

Whereas, on 16.06.2026, upon expiry of the aforesaid extended period, *Mr. Mohd Jawad* again approached GAD with a representation seeking further extension of the joining time, which was accordingly extended up to 16.07.2026 vide Order No. 291-LA (GAD) of 2026 dated 19.06.2026;

Whereas, before expiry of the aforesaid further extended period, *Mr. Mohd Jawad* again approached GAD on 13.07.2026 seeking further extension of the joining time, which was extended up to 07.08.2026 vide Order No. 343-LA (GAD) of 2026 dated 28.07.2026;

Whereas, on 05.08.2026, *Mr. Mohd Jawad* submitted an undertaking expressly conveying his unwillingness to join the post of Orderly in the General Administration Department;

Whereas, the aforesaid undertaking unequivocally establishes that *Mr. Mohd Jawad* has declined to avail the appointment offered to him pursuant to the aforesaid selection and appointment process;

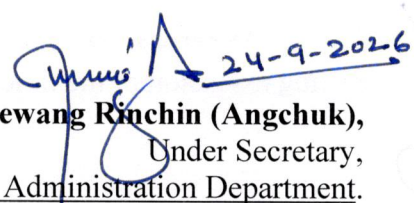
Now, therefore, in exercise of the powers vested in the competent authority and in view of the unwillingness expressed by *Mr. Mohd Jawad* to join the post, the Appointment Order No. 142-LA (GAD) of 2026 dated 19.03.2026, insofar as it relates to the appointment of *Mr. Mohd Jawad* as Orderly in the General Administration Department, UT of Ladakh, is hereby cancelled with immediate effect.
