Whereas, the Ladakh Subordinate Services Staff Selection Board (LSSSSB), vide Public Notice No. 45 dated 18.08.2026, issued the final Select List for the post of “Junior Assistant/Tabulator/Election Assistant (Junior Scale)” under Post Code LSB2513 and recommended; inter alia, the name of *Ms. Edzes Dolma* D/o Sh. Thukjay Ishey, R/o Togochey, Terechey, Diskit, Nubra, for appointment to the post of Junior Assistant in Pay Level-4 of the Pay Matrix, Structure (₹25,500–81,100);

Whereas, pursuant thereto, GAD, vide File No. A-12/17/2024-GAD SEC dated 21.08.2026, issued an Offer of Appointment to three candidates, including *Ms. Edzes Dolma* at S. No. 1, for appointment to the post of Junior Assistant in Pay Level-4 of the Pay Matrix, Structure (₹25,500–81,100), stipulating therein a period of fifteen (15) days for acceptance of the said offer, which was duly accepted by *Ms. Edzes Dolma* on 27.08.2026;

Whereas, consequent upon such acceptance, an Appointment Order was issued inter alia in favour of *Ms. Edzes Dolma*, along with two other candidates, vide Order No. 395-LA (GAD) of 2026 dated 28.08.2026, stipulating therein that she was required to join the post within a period of one (01) month from the date of issuance of the said Appointment Order;

Whereas, prior to joining the post, *Ms. Edzes Dolma*, vide undertaking dated 23.09.2026, expressly conveyed her unwillingness to join the post of Junior Assistant in the General Administration Department;

Whereas, the aforesaid undertaking unequivocally establishes that *Ms. Edzes Dolma* has declined to avail the appointment offered to her pursuant to the aforesaid selection and appointment process;

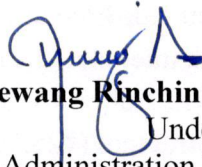
Now, therefore, in exercise of the powers vested in the competent authority and in view of the unwillingness expressed by *Ms. Edzes Dolma* to join the post, the Appointment Order No. 395-LA (GAD) of 2026 dated 28.08.2026, insofar as it relates to the appointment of *Ms. Edzes Dolma* as Junior Assistant in the General Administration Department, UT of Ladakh, is hereby cancelled with immediate effect.
