- The appointees shall be on probation for a period of two years with effect from the date he/she joins the post. During the period of probation, the appointees will be liable to be discharged from service at any time without any notice, if:
 - On the basis of his/her performance or conduct, he/she is considered unsuitable for further retention in service, or
 - He/She is otherwise found ineligible or unsuitable to be retained in the service.
- The above appointees have been declared medically fit by the Prescribed Medical Authority.

This appointment is subject to the verification of character and antecedents; verification of the certificates of reserved category; and verification of certificates / marksheets relating to the educational qualification and such essential requirements as prescribed in the Union Territory of Ladakh Handicraft (Subordinate) Service Recruitment Rules, 2022.
4. Other terms & conditions will be governed by the relevant Central Civil Service Rules & Orders in force from time to time.
