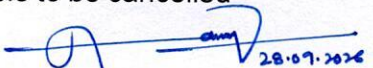

PUBLIC NOTICE No. 51

Subject: Issuance of Select list for the post of Supervisor/ Auditor in the Cooperative Department issued vide Advertisement Notice No. 01 of 2025 - Post Code LSB2511-Reg.

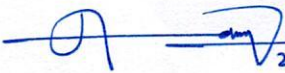
1. The Ladakh Subordinate Services Staff Selection Board (LSSSSB), vide Advertisement No. LSSSSB/ 2025/ 01 dated 28.07.2025, had advertised 10 vacancies (09 ST, 01 EWS, 01 VH-PwBD) for the post of Supervisor / Auditor in the Cooperative Department of the Administration of UT of Ladakh.
2. The OMR-based written examination for the said post was conducted in the month of April, 2026, and the roll number-wise marks obtained by the candidates who appeared for the examination were declared in May, 2026.
3. Vide Public Notice No. 37 dated 01.07.2026 and Public Notice No. 47 dated 31.08.2026, candidates were provisionally shortlisted for Document Verification on the basis of merit in the OMR-based examination, and the Document Verification of provisionally shortlisted candidates was subsequently conducted by the concerned Administrative Department.
4. Based on the Document Verification reports of both rounds received from the concerned Department i.e. Cooperative Department in respect of the **Post Code LSB2511**, the Select List has been prepared for Post Code LSB2511 and hereby notified as **Annexure-I** to this Notice.
5. While due care has been taken in preparing the Select List, the Ladakh Subordinate Services Staff Selection Board (LSSSSB) reserves the right to rectify any error or omission therein, if detected at any stage.
6. Further, appointment of the selected candidates shall be subject to verification of original documents, fulfilment of eligibility conditions, character and antecedent verification, and other formalities as prescribed by the Appointing Authority in the concerned Department of Administration of UT of Ladakh.
7. If at any stage it is found that a candidate does not fulfil the prescribed eligibility criteria or has furnished incorrect/false information, his/her candidature shall be liable to be cancelled without any further notice.

8. The recommendations of the selected candidates are being forwarded to the concerned Administrative Departments for issuance of offer of appointments and further necessary action.

9. The Wait/Reserve List shall be operated strictly in order of merit only upon communication from the concerned Department that a vacancy has remained unfilled due to non-acceptance of the offer of appointment or non-joining of a selected candidate. The Wait/Reserve List shall be operated only against the originally notified vacancies and shall not be used to fill any future, additional, or newly created vacancies.
