Subject:- **Appointment of candidate to the post of Wildlife Forester (Non-Gazetted) in Forest, Ecology, and Environment Department of the Administration of Union Territory of Ladakh, in Level-4 of pay matrix (Rs. 25500-81100).**

Reference: 1. Select List Vide No. SECY/LAHD-SSRB/Sel List/2026/1696-1700 dated 21.07.2026 issued by LAHD-SSRB.
2. Offer of Appointment vide Memorandum No. APCCF/Appointment/2026/E.Comp No. 17425/688-92 dated 06.08.2026.

Consequent upon the selection list issued by the Leh Autonomous Hill Development Council- Subordinate Services Recruitment Board (*referred above*) and with the approval of the Competent Appointing Authority, you are hereby appointed to the post of **Wildlife Forester** (Non-Gazetted), in the Department of Forest, Ecology and Environment of the Administration of Union Territory of Ladakh, in the pay Level-5 of pay matrix (Rs. 29200-92300) along with other allowances as admissible under the Rules, with immediate effect:

2. This appointment shall be subject to the following conditions:

- i. *The appointee shall be on probation for a period of two years, with effect from the date of his joining the post. During the period of probation, the appointee will be liable to be discharged from service at any time without any notice, if:*
 - *On the basis of his performance or conduct, he is considered unsuitable for further retention in services, or*
 - *He is otherwise found ineligible or unsuitable to be retained in the service.*
- ii. *The appointee has been declared medically fit by the Prescribed Medical Authority.*
- iii. *This appointment is subject to the verification of character and antecedents, verification of the reserved category certificate(s) and the certificates/mark sheets relating to educational qualifications through the proper channel. In the event that such*

verification reveals any claim to reserved category, academic qualification, or mark sheet, etc to be false, the services shall be terminated forthwith, without assigning any reason or prior notice, and without prejudice to any further action that may be taken under the provisions of the Indian Penal Code for submission of false certificates.

- iv. The appointee should furnish a declaration that you were not on any previous occasion dismissed from service under any department of Government or convicted by a Court of Law, and that no case is pending against you in any court of law
- v. The appointee should undergo mandatory forestry training as prescribed in the Union Territory of Ladakh Forest (Wildlife) (Subordinate) Service Recruitment Rules, 2021 and Union Territory of Ladakh Forest (Wildlife) (Subordinate) Service Recruitment (Amendment) Rules, 2024.
- vi. Other terms and conditions of service will be governed by the applicable rules and orders in force from time to time.
- vii. The inter-se seniority of the above appointee shall be worked out as per the extent applicable service rules.
- viii. The appointment of the appointee shall be subject to the outcome of writ petition (s), if any, pending before any Competent Court of Law.

3. It is further ordered that;

- i. The services of the candidate appointed as **Wildlife Forester** is placed at the disposal of the **Chief Wildlife Warden, UT of Ladakh** for further deployment in the Sub-ordinate Office / Division of the Forest Department.
- ii. The appointee shall report for duty against the post of **Wildlife Forester** to the office of the **Wildlife Warden, Leh** within a period of one (01) month from the date of issuance of this Order, failing which his appointment shall be deemed to have been cancelled ab initio.
- iii. The expenditure towards his pay and allowances shall be debited against the head of "Salaries" from the Budget Head associated with his respective place of posting upon his deployment in the Sub-ordinate offices of the Department.
- iv. The appointee shall be governed by New Pension Rules as notified vide No. 01/01/20014-1 pension, dated: 18/08/2008.

4. This issues with the approval of Appointing Authority in the administration of the Union Territory of Ladakh.

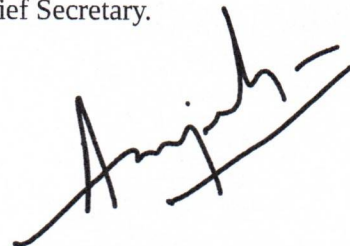
