Subject: Ad-hoc/Officiating Promotion of Assistant Registrar, Cooperatives to the post of Deputy Registrar, Cooperatives in the Junior Scale.

Whereas, a total of 04 posts of Deputy Registrar, Cooperatives in the Junior Scale stand apportioned to the Union territory of Ladakh, of which 02 posts are earmarked to be filled by promotion; and

Whereas, all the 02 promotion quota posts are presently lying vacant, resulting in an acute shortage of officers and adversely affecting the functioning of the Cooperative Department, which are presently being managed through additional charge and other interim arrangements; and

Whereas, regular promotions against these vacancies could not be effected due to the non-finalization of the Recruitment Rules governing the post of Deputy Registrar, Cooperatives; and

Whereas, the Ministry of Home Affairs, Government of India, vide Letter No. 12011/12/2020-L dated 27.07.2026, has conveyed approval for effecting ad-hoc promotions as an interim arrangement pending finalization of the Recruitment Rules; and

Whereas, the Cooperative Department has prepared and notified the final seniority list of Assistant Registrar, Cooperatives, vide Order No. 19-Coop/UTL/of 2026 Dated 14.08.2026, and the eligible officer has been considered in order of seniority against the available promotion quota vacancies after verification of eligibility, APARs, integrity status, vigilance status and apportionment details of the officer.

Now, therefore, in pursuance of the approval conveyed by the Ministry of Home Affairs, Government of India, vide Letter No. 12011/12/2020-L dated 27.07.2026, permitting ad-hoc promotions pending finalization of the Recruitment Rules, and with the approval of the Hon'ble Lieutenant Governor, Union territory of Ladakh, the following officer is hereby promoted, on ad-hoc/officiating basis, to the posts of Deputy Registrar, Cooperatives in the Junior Scale (Pay Level-8: 47600-151100) against the available promotion quota vacancy, purely as an interim arrangement with immediate effect:

The above ad-hoc/officiating promotion shall be subject to the following conditions:

- i. The promotion is purely ad-hoc/officiating and temporary in nature and shall not confer any right upon the officer for regular promotion, seniority, confirmation or continuation in the promoted grade.
- ii. The officer shall not claim retrospective regular promotion, seniority or any consequential service benefits on the basis of the ad-hoc/officiating promotion.
- iii. The promotion shall remain subject to the finalization of the Recruitment Rules for the post of Deputy Registrar Cooperatives, recommendations of the Departmental Promotion Committee, wherever applicable, and the outcome of any court case(s), administrative proceedings or Government orders affecting the said promotion.
- iv. The pay of the officer shall be regulated under the provisions of FR 22(1)(a)(I) and other applicable rules from the date of assumption of charge of the higher post.
- v. The officers shall continue to hold the promoted post until further orders or till regular promotion are made in accordance with the notified Recruitment Rules, whichever is earlier.
- vi. Transfer and Posting order of the above officer shall be issued separately.
