The above ad-hoc promotions shall be subject to the following conditions:

1. The above promotion shall be purely on temporary basis, as an interim arrangement against the available vacant posts under the promotional quota, and shall not confer upon the officers to claim any right to regular promotion, seniority or continuance in the higher post.
2. The aforesaid promotion shall be subject to the outcome of the regular selection/promotion. The Department shall initiate and complete the process for convening the Departmental Promotion Committee (DPC) and

regular promotion to the said posts shall be made strictly in accordance with the Recruitment Rules and recommendations of the DPC.

3. The pay of the officers shall be regulated under the provisions of **FR 22(I)(a)(1)** and other applicable rules from the date of assumption of charge of the higher post.
4. The above promotion shall remain operative until the posts are filled on regular basis or until further orders, whichever is earlier.
5. The above officers shall continue to work at their place of posting till further orders.
