The PMC has sanctioned General Guidelines under Centrally Sponsored Silk Samagra -2 Scheme for Maharashtra on dated 18th January 2023. These points are as follows.

- 1. Farmers_who cannot /have not benefitted from MGNREGA scheme /Pokara Scheme and other schemes can be given the benefit of centrally sponsored Silk Samagra -2 Scheme.
- 2. The benefit of this scheme cannot be given to those who are in govt Jobs.
- **3.** State voluntary institution SPVS (special purpose vehicle) corporate finance institution ,voluntary service institution, KVKs,Self help groups,Panchayat Raj Institution, Umaid, MKSP,BAIF,NGO, Universities may be allowed to submit special projects for the implementation of this project.
- **4.** No age requirement of beneficiary.
- **5.** Beneficiary names of 7/12, Extract of 8/A and map require farmers residing in talukas, Districts with irrigation facilities can avail the benefit of the schemes.
- **6.** Residing farmers in municipals, Nagar panchayat areas, small land holders with minimum 1 acre & bigger farmers can avail from this scheme.
- **7.** Must have at least 5 to 10 beneficiaries of mulberry Plantation in a village in exceptional circumstances decision should be taken by SDO also RSO permission should be taken.
- **8.** Complete procedures of farmers who facilitate the criteria should be prepared by the field staff and sent through the SDO with the recommendation of the District coordination committee to the Regional Sericulture office for approval with in 15 days from the date of receipt of the proposal.
- **9.** Regional Sericulture officer should scrutinize all the proposals coming from the DSO and submit the complete proposal to the Directorate of Sericulture with recommendation for further action.
- **10.** In this Scheme, the proposal should be submitted with recommendation only after giving the prior consent of the beneficiaries of the project .If the proposal is sent to this office without prior approval or found to be so,the concerned DSO will be held responsible.
- **11.** If the family has 7/12 (Common) of the joint land, if one of the farmers wants to cultivate Mulberry or other components utilized it will be mandatory to obtain consent letter from members on Rs.100/- affidavit Stamp paper at Setu Kendra.
- **12.** It will be mandatory to submit the original documents along with the proposal along with the original application.
- **13.** After disbursement of subsidy under centrally Sponsored Silk Samagra-2 Scheme ,it will be mandatory to keep 3x2 ft sheet board with the subsidy information in front of the Mulberry Plantation ,Rearing house,MRM,ARM,Twisting Unit, Loom up gradation etc.
- **14.** It will be mandatory to maintain Asset Register farmer wise, year wise & Scheme wise of Centrally Sponsored Silk Samagra -2 scheme as well as state sponsored scheme.

- **15.** Proposals of farmers who planted 2.00 acres & 1.00 acre of Mulberry plantation of centrally Sponsored Silk Samagra -2 Scheme should be submitted with separate recommendation along with site visit report.
- **16.** SDO/RSO cannot change the grant .If changes are required a separate recommendation should be sent to this office before submitting the proposal.
- **17.** Construction of Rearing house 50x20 ft with RCC column is eligible to the beneficiary who has planted 2.00 acres of mulberry . However if their situation is not available then it is acceptable to construct Rearing house as given size for 1.00 acre of Tin Shed or Cement sheet Shed.

On this Point no 17 Shri. Hake Deputy Director, Regional Sericulture, Aurangabad Said that instead of RCC column you should change brick column and instead of RCC Slab ASBESTOS SHEET/TIN SHEET/CEMENT SHEET for 2.00 acre plantation because the RCC rearing house cost is very highly.

Dr. Jitendrasingh Scientist –C, CSB, and Ranchi if the guidelines have prepared by CSB you cannot change it.

Shri. Paramesha Assistant Secretary (Tech) & Nodal officer of Maharashtra said that you can only slightly change. Structure cannot be changing it.

Lastly Hon'ble Chairperson and all Member of PMC has decided those the Point 17 who has written in guidelines there is no change.

- **18.** Those beneficiary who have 2.00 acre & 1.00 acre plantation they should build Antiroom Leaf Chamber & Disinfection Tank adjacent to RH.
- **19.** For Drip Irrigation Set/ Sprinkler irrigation a maximum price of Rs.60000/- (Including GST, Materials, Transportation & Erection) for 1.00 acre and a maximum price of Rs.1.00 lakh for 2.00 acres is proposed.
- **20.** Mulberry Plantation are required to have 5500 mulberry sapling per acre not less than 5500 mulberry sapling for 01.00 acre. (Unit cost of RS.0.60 lakh/per acre) & Unit cost of Rs.1.20 lakh for 02 acre only.
- **21.** One acre plantation Rearing house should be constructed with Koba/flooring Side wall 4ft brick wall with plaster, Iron poles &Iron Sheet /Cement sheet is required.
- **22.** Two acre Plantation Rearing house Should be constructed with Koba/flooring Side wall 4ft brick wall with plaster ,RCC Slab with RCC Column is required
- **23.** Leaf chamber and Disinfection tank is required for both models of RH.Leaf chamber will be 20x8 ft for 2.00 acres model I & 10x8 ft for 1.00 acre model II and 5x4ft disinfection tank will be both of this model.

On this point 23 Shri Hake Said that instead of Leaf chamber cum Antiroom you should write only Leaf Chamber. The PMC has considered this Point no 23.

- 24.It is mandatory to have **Note camp camera photos** of the construction with the farmer before the construction of the rearing house while the work is in progress after the work is completed.
- 25. Bills for rearing equipment should be submitted along with the GST Bill. Only actual cost of the material will be admissible for subsidy.
- **26**. Beneficiaries who have taken the benefit of Mulberry Plantation, construction of Rearing house, Drip Irrigation, Assistance for supply of Rearing equipments before 5 Years will not get the benefit again.

27. Farmers who planted 2.00 acres of Mulberry Plantation will get subsidy of 2.00 acre for Mulberry cultivation but according to the financial condition of the said beneficiaries, if they construct by Tin Sheet of Rearing house for size 50x20ft or 50x22 or 60x22ft accordingly they will be eligible to get subsidy only in 1.00acre only.

On this Point no 27. Shri Hake said that in CSB guidelines Model II for RH SIZE is 30x20ft. You should change it this size.

The PMC gave permission to Mr.Paunikar SDO II Nagpur to talk about MODEL II rearing house. He said that in Maharashtra level Branch system is used at farmer level and if the Rearing house size 30x20 ft will be used at the time of rearing this will not suitable it will be congested at the time of rearing .That's why modification of rearing house is necessary in Maharashtra for Model II.

Assistant Director, Shri Dhawale DOS, M.S.Nagpur said that those Model II who has mentioned in Point no 27 is suitable for Maharashtra.

Then the lastly the PMC has decided that Farmers who planted 2.00 acres of Mulberry Plantation will get subsidy of 2.00 acre for Mulberry cultivation but according to the financial condition of the said beneficiaries, if they construct by Tin Sheet/Cement sheet of Rearing house for <u>size 30x20 ft and above</u> accordingly they will be eligible to get subsidy only in 1.00acre of Rearing house.

- 28. Beneficiaries who require a minimum 30X20ft and above Tin shed /Cement shed. If the farmers want we will rear more silkworm eggs they can construct rearing house 50x22ft or 60x22 ft .The said beneficiaries will be paid the subsidy for construction of rearing house for 1.00 acre.
- 29. The unit cost for Rearing house for the Model I 50X20 ft (1000 SQ.FT) for 2.00 acre with RCC construction will be fixed as 450000/- is as Silk Samagra -2 Scheme. But Model II rearing house size is 30x20ft (600) ft with RCC construction as per silk samagra-2 scheme. This Model has been modified rearing house size will be minimum 30x20ft (600 sq.ft) and above with tinshed/Cement sheet shed is compulsory and its unit cost will be Rs.325000/- and also sharing pattern is as per silk Samagra -2 Scheme.
- **30**. The PMC decided that under Silk Samagra -2 scheme ,One beneficiary will be provided with the assistance for mulberry plantation ,drip irrigation or sprinkler irrigation ,Rearing house ,rearing equipment & Disinfectant for 02 acre only not more than 02 acres. Farmers can mulberry kisan nursery /Vanya nursery upto 5 acre only not more that. But DSO officer should maintain Demand & supply ratio. The unit cost for mulberry plantation, Drip irrigation, rearing house, rearing equipment & Disinfectant & all other scheme will be as per Silk samagra -2 norms for state sericulture.
- 31. Chawki rearing house should be 42x30x16 ft. Beneficiary should rear 5000 dfls in every batch. Minimum capacity will be 1.50 lakh dfls/year to supply chawki worms to farmers. .Also, should have incubation centre unit. Cost of this unit is 1300000/- sharing pattern is as per silk samagra -2 norms.
- **32:-The** PMC decided that Beneficiary Empowerment programme unit cost of Rs.7000/-per beneficiary. CSB share is 100%.In BEP Rs.5000/-for beneficiary

Training & Rs.2000/- per beneficiary for sericulture exposure visit. Beneficiary Training period will be 07 days which includes wage compensation ,Lodging &boarding ,Training material &Training cost,Study material and if any travel compensation to the beneficiaries . Experience farmers /Expert will give guidance at the time beneficiary training they should give stipend as per norms of Vanamati/ Yashda Govt of Maharashtra institute .

Exposure visit:-This program is meant for visit to different clusters/establishments/research institution to have an exposure to the latest knowhow and sericulture technologies and processes in the field depends on fund availability exposure visit may arrange of interested farmers. Duration of exposure visit is **02 days**.

<u>Point no 33:-</u> The PMC decided that 1.00 acre for kisan mulberry seedlings unit cost is Rs.1.50 lakh. The cost is for the following items 1. Preparation of Nursery beds. 2. Cost of planting material 3.Maintance of Nursery garden. iv. Cost of Tools machinery .V. <u>Cost of Inputs has been considered</u> by PMC.

In 1.00 acre Nursery shall have 112500/-live mulberry plants with Geotagging photo. Mulberry sapling of minimum height will be 2 to 2.5 ft for new plantation & receipt of farmers list should be necessary with verification proposal of concerned SDO.

<u>Point no 34:-.</u> The PMC decided that while applying under centrally Sponsored of Silk Samagra -2 schemes for post cocoon Sector proposal following document is necessary for PMC approval.

- 1. Grant application for MRM/ARM/Twisting unit/Loom up gradation & other components of Post cocoon sector.
- 2. Presanctioned letter should be given to the beneficiary from the District Sericulture officer of concerned district.
- 3. copy of first page of Nationalized bank passbook, photocopy of Aadhar card, original copy of 7/12,8/A & map
- 4. For MRM 1200 sq.ft is necessary and if land is not available you can make rent agreement/lease agreement for MRM at least for 10 yrs.
- 5. <u>15000 Sq.ft Non agriculture own land after issuing the sanctioned letter</u> is mandatory for IARM(400 Ends) & 7000 to 8000 sq.ft for IARM (200 Ends) and 3000 to 4000 sq.ft for IARM (120 ends) if land is not available you can make Registered contract agreement at least for 10 to 15yrs.
- 6. No objection certificate from Grampanchayat, Municipalty, Nagarpanchayat etc
- 7. Photo of shed site for construction of reeling machinery <u>after issuing</u> sanctioned letter.
- 8. Proof of bank balance Statement during the interview
- 9. In bank account minimum 25% beneficiary Share of the unit cost is necessary for further action.

- 10. Affidavit, Guarantee letter, Agreement should be attached with the proposal Particular in Prescribed format.
- 11. Quotation from central silk board approved /authorized vendor of Post cocoon sector proposal.
- 12. Proof of electric bill and water facility after issuing selection letter
- 13. If the land or commercial plot is available in MIDC will be preference for selection of beneficiary of ARM.
- 14. Training Certificate of particular Unit minimum for 8 days. Those Enterpreneur who has taken 03 months training of particular unit they will give preference.
- 15. Central Silk Board Feasilibility report should be attached with the proposal.

All other General guidelines Points under Centrally sponsored Silk Samagra -2 scheme for Maharashtra which have been mentioned in agenda and explanatory notes dated 18.01.2023 there will be no change and approved by PMC. The PMC has also instructed Unit cost of component and Sharing pattern are same as per under silk Samagra -2 schemes.

As per above, after receiving the proposal from the Enterpreneur of MRM/IARM/Twisting unit & other post cocoon sector proposal should be placed in District coordination committee after recommendation of this the said proposal should be sent to Regional Sericulture office along with all original document. The Regional Sericulture office should sent the proposal along with clear recommendation to the DOS, Nagpur for further action. DOS Nagpur should place the proposal before the PMC. The PMC will take decision of this. After sanctioned the proposal in PMC then PMC will take a interview for selection of entrepreneur.

The Regional level newly constitutes the committee only for post cocoon sector proposal. The members of the committee will be is as under

- 1.Deputy Director / Assistant Director Regional Sericulture office Chairman
- 2. Zonal officer or Representative STSC, CSB, Dharwad- Member
- 3. District Sericulture officer Member
- 4. Head of REC or Representative, CSB- Member
- 5. Senior Technical Assistant of Division or Senior Field Assistant Member convener.
- 6. Non Govt organization /SHG Chairman or representative Member
- 7. Farmer involved in Excellent Sericulture in the field Member

8. State level Sericulture coordination committee Non official member – Member

The above points has been discussed in PMC dated 18th January 2023. Then the PMC has approved of these above points for implementation of centrally sponsored under Silk Samagra -2 Scheme in Maharashtra.
