## **CIRCULAR**

In pursuance to the approval dated 08.12.2017, Judicial Officers and the ministerial staff / officials of Delhi State Legal Services Authority / Delhi High Court Legal Services Committee / District Legal Services Authorities/ Permanent Lok Adalat — I & II are hereby allowed to avail winter vacations w.e.f 26.12.2017 (Tuesday) to 30.12.2017 (Saturday) during the calendar year 2017 on the pattern of High Court of Delhi & its sub-ordinate departments on the following terms and conditions:-

- Delhi State Legal Services Authority / Delhi High Court Legal Services Committee /
  District Legal Services Authorities/ Legal Service Clinic at Jail Section of this Authority at
  Tihar Jail shall remain open on all working days i.e. 26.12.2017 to 30.12.2017 during the
  winter Vacations.
- 2. All the employees / Officials working on contract basis with the Authority shall remain present at their respective place of posting on each working day during vacation and shall carry out necessary work.
- 3. JJBs and PLA I & II shall remain closed during the winter vacation. However, the contractual staff of JJBs and PLA-I & PLA-II shall perform their duties at Central Office, DSLSA during said vacations.
- 4. No officers and officials shall be allowed to prefix or suffix any kind of leave except casual leave with the Winter Vacation. If any, employee takes leave except Casual Leave, the whole period of Winter Vacations, will be treated as leave of the kind due.
- 5. The Secretaries of all 11 District Legal Services Authorities shall ensure that the accused in custody are represented by the remand advocates in the courts of Duty Magistrates during the Winter Vacation. The contact number of empanelled legal service counsels who are on remand duties with the Magisterial Courts during the winter vacations may be provided for the help of Legal Aid seekers who may visit the concerned DLSAs or DSLSA to cater their legal aid needs. They shall further ensure that front office of respective DLSAs remains open on each working day during winter vacation.

- 6. The Secretaries concerned shall also ensure that the Legal Services Clinics functional under their control in the judicial Lockup shall also remain open during the winter vacation.
- 7. The officials posted at Jail Section are allowed to avail Commensurate Compensatory
  Leave during the First Quarter of the subsequent calendar year.
- 8. Violation of any kind of condition / instruction shall render the erring official liable to strict disciplinary action.
