PROTECTION OF WOMEN FROM DOMESTIC VIOLENCE

All women who are being subjected to any act of domestic violence are entitled to free legal aid and advice irrespective of their income.

WHAT IS DOMESTIC VIOLENCE?

"Physical abuse"- any act that causes bodily injury or hurt. E.g. beating, kicking, punching, etc.

"Sexual abuse"- any humiliating or degrading sexual act. E.g. forced sexual intercourse etc.

"Verbal and emotional abuse"- insults, threat causing harm or injury.

"Economic abuse"- deprivation of the basic necessities of life.

Against whom complaint can be filed under Domestic Violence Act, 2005?

Domestic Violence complaint can be filed against the person with whom the woman victim is in domestic relationship or/and against his family/relatives.
