How to apply for Legal Aid?

1. Go to the official website of NALSA (nalsa.gov.in) and click on the "Apply for Legal Aid" tab.
2. Reach out to the DLSA office in your district.
3. Check if you meet the eligibility criteria for legal aid (such as income, socio-economic factors).
4. Fill the application form for legal aid, which can be downloaded from NALSA website or obtained from DLSA office.
5. Submit application form along with required documents, such as proof of income, identity & residence.
