## BENEFITS UNDER MAINTENANCE AND WELFARE OF PARENTS AND SENIOR CITIZENS ACT, 2007

### What is Maintenance?

It refers to the financial support provided by children, grandchildren, or legal heirs to ensure the well-being of senior citizens and parents.

### Essential Needs

Food, shelter, healthcare, and other basic requirements to promote their dignity and quality of life.



### Maintenance Obligations

It is legally mandatory for children and heirs to provide maintenance for parents and senior citizens unable to take care of themselves.

### Who Can Apply

Senior citizens (aged 60 and above) and parents (including adoptive parents).

### Against Whom

Maintenance can be claimed from children (biological or adoptive), grandchildren, or legal heirs if they fail to provide adequate support.

### How to Apply for Legal Aid

Senior citizens can apply for legal aid at DSLSA website or by visiting the front office (at nearest DSLSA) to fill out the required application form and submit relevant documents (identity proof, income certificate etc.)



### Legal Remedies

Senior citizens can file complaints against children or relatives for neglect or failure to provide maintenance. The maintenance tribunal has the authority to ensure compliance and provide remedies.

### Relief

Financial maintenance

Restoration of rights related to property assets if denied.
