
The other terms and conditions shall remain the same as mentioned in Tender Notice no. DLSA/GA/10/2003/12747 dated 13/10/2016 which is as follow :-

1. The minimum reserve price for Maurti Esteem is Rs. 22000/- (Rs. Twenty two thousand only) and for Hero Honda Motorcycle is Rs. 1500/- (fifteen hundred only).
2. Only bidder who deposit the caution money of Rs. 2200/- for Maruti Esteem and Rs. 150/- for Motorcycle in the form of Bank draft of any Nationalized Bank in favour of "DDO, Delhi State Legal Services Authority", shall be allowed to participate in auction/bid. The caution money of all the unsuccessful bidders will be refunded on the same day of the auction/bid.
3. The caution money shall be accepted on 23/12/2016 between 10 A.M. to 2:30 P.M. only.
4. The successful bidder shall deposit the amount of bid ((balance amount after adjustment of caution money deposited) in the form of Bank draft of any Nationalized Bank in favour of "DDO, Delhi State Legal Services Authority" on the same day of auction/bid or latest by next working day upto 3 P.M.
5. The successful bidder shall remove the auctioned vehicles from Patiala House Court Complex on the same day or latest by next working day upto 5 P.M. of auction/bid failing which the caution money shall be forfeited. On failure to remove the vehicle within the aforesaid time span, ground rent @ 1% of the bid amount shall be charged for each day or part of the day till removal of the vehicle from the aforesaid place. If the ground rent so charged, exceeds the sale price

deposit, then the bidder shall cease to have any right on the vehicle and the amount deposited by him shall be adjusted towards ground rent.
