THE AUCTION WILL BE GOVERNED BY THE FOLLOWING TERMS AND CONDITIONS :

- (1) **The minimum reserve price for the articles is Rs. 1.90/- (Rs. One lac & ninety thousand only).**
- (2) Only bidder who deposit the caution money of Rs. 47,500/- (Rs. Forty seven thousand & five hundred only) i.e. 25% of reserve price in the form of Bank draft of any Nationalized Bank in favour of **"DDO, Delhi State Legal Services Authority"**, shall be allowed to participate in auction/bid. The caution money of all the unsuccessful bidders will be refunded on the same day of the auction/bid.
- (3) The caution money shall be accepted from 12/08/2016 to 26/08/2016 between 10 A.M. to 2:00 P.M. only.
- (4) The successful bidder shall deposit the offered bid amount or atleast 50% amount of bid amount ((balance amount after adjustment of caution money deposited) in the form of cash or in the form of Deposit-at-Call-Receipt (DACR) within 24 Hrs. after day of auction/bid. The remaining balance if any shall be deposited in cash latest by next working day on 27/08/2016 upto 3 P.M.
- (5) The successful bidder shall remove the auctioned articles after depositing the full payment from Permanent Legal Services Clinic, Shaheed Bhagat Singh Place, Gole Market, New Delhi on the same day or latest by next working day on 29/08/2016 upto 4 P.M of auction/bid failing which the caution money shall be forfeited. On failure to remove the articles within the aforesaid time span, ground rent @ 1% of the bid amount shall be charged for each day or part of the day till removal of the articles from the aforesaid place. If the ground rent so charged, exceeds the sale price deposit, then the bidder shall cease to have any right on the articles and the amount deposited by him shall be adjusted towards ground rent.

- (6) VAT as admissible shall be paid on the bidding cost by the successful bidder.
- (7) Once the bid/auction is accepted, it cannot be withdrawn and it will be assumed that goods/articles have been accepted by the party on **"as is where is basis"**.
- (8) All the expenses for loading, unloading and shifting of the goods/articles will be borne by the buyer.
- (9) The EMD received from unsuccessful bidders will be returned to them without any interest.
- (10) Only one person shall be allowed to accompany the bidder/kabari .
- (11) The rates to be offered shall be for the entire lot and no part rates will be accepted.
- (12) Competent Authority reserves the right to accept or reject any of the bid without assigning any reasons.
