- 1. The envelope carrying the bid must be superscripted in capital letter with "OFFER FOR AUCTION SALE OF VEHICLE". The Minimum reserved price (Offset Price) of the vehicle is Rs. 37,000/- (Rs. Thirty seven thousand only).
- 2. The intending tenderers are advised to inspect the above vehicle parked in the Patiala House Court Complex between 11:00 A.M. to 4.00 PM, on any working day before submitting the tender. Each tender must accompany an earnest money deposit of Rs. 3700/- (Rs. three thousand & seven hundred only) in the shape of Bank Draft of any Nationalized Bank in favour of 'DDO, Delhi State Legal Services Authority', which will be refunded to the tenderers, whose tenders are not accepted except in case of the successful bidder. The bid price offered shall not be less than the minimum (offset) price as mentioned above.
- 3. The tender should reach the undersigned by registered post/speed post on or before dated 23/12/2016 upto 3.00 PM at the latest and tenders received shall be opened by the Auction Sale Committee in the Central Office, Delhi Legal Services Authority, Patiala House Court, New Delhi on 24/12/2016 at 11.00 A.M. in the presence of the tenderers or their authorized representatives. The undersigned will not be held responsible regarding late submission/received of tender in any manner.
- 4. The highest tenderer, whose tender is accepted shall deposit immediately 25% of the offered amount there & then as initial deposit. He shall deposit the balance amount within seven days of the deposit of the initial amount. If highest bidder does not accept the offer of sale of vehicle for any reasons whatsoever it may be, and

If the ground rent so charged, exceeds the sale price deposit, then the tenderer shall cease to have any right on the vehicle and the amount deposited by him shall be adjusted towards ground rent. Tools implements of spare parts shall not be delivered with vehicle.
