# THE AUCTION WILL BE GOVERNED BY THE FOLLOWING TERMS AND CONDITIONS:

- (1) The Auction/bid is scheduled on 03/11/2016 at 11:30 A.M. at Permanent Legal Services Clinic, Gole Market, New Delhi.
- (2) The items lying at PLSC, Gole Market, New Delhi may be available for inspection between 10 A.M. to 2 P.M. on all working days from 17/10/2016 to 02/11/2016 & on 03/11/2016 from 10:00 A.M. to 10:45 A.M. only. For this purpose Mr. Ramesh Chand Dogra, Assistant may be contacted over Tel. no. 23071624. The interested parties may participate for bid/auction on the date, time and venue mentioned above.
- (3) The minimum reserve price for the articles is Rs. 1,42,500/- (Rs. One lac forty two thousand and five hundred only ).
- (4) Only bidder who deposit the caution money of Rs. 35,625/- (Rs. Thirty five thousand six hundred & twenty five only) i.e. 25% of reserve price in the form of Bank draft of any Nationalized Bank in favour of "DDO, Delhi State Legal Services Authority', shall be allowed to participate in auction/bid. The caution money of all the unsuccessful bidders will be refunded on the same day of the auction/bid.
