  - The firm shall maintain the equipment as per manufacturer's guidelines and shall use standard OEM components for replacement. (ii)

### The other terms and conditions for awarding the AMC shall be as under :-5.

- The initial period of contract will be for one year from the date of award of contract. The rates quoted will remain in force for the full period of contract. No (i) demand for revision of rate on any account shall be entertained during the contract period. The AMC can be extended, if so desired by the Competent Authority, based on the performance of the service provider.
- The firm/company will prepare logbooks for each of the machine to be taken under the AMC and Preventive maintenance like special cleaning of the Machine (ii)
- The service engineers would take up any reported fault within two hours. As far as possible, the repairs would be carried out on-site. However, in case the (iii) equipment is taken to the workshop, the firm would provide a standby for the
- The firm must carry out repairs within 24 hours, to the satisfaction of the user. A call sheet duly signed by user and should be submitted to the concerned Branch (iv)after successful repair.
- Each tender must accompany an earnest money deposit of Rs.10,000/- (Rs. Ten thousand only) in shape of Bank Draft of any Nationalized Bank in favour of 'DDO, (v) Delhi State Legal Services Authority', which will be refunded to the tenderers, whose tenders are not accepted except in case of the successful bidder.
