THE AUCTION WILL BE GOVERNED BY THE FOLLOWING TERMS AND CONDITIONS:

- 1. The interested parties may participate for bid/auction on the 26/03/2020 at 2:30 P.M. onwards at Central Office, Patiala House Courts, New Delhi. The minimum reserve price for the articles is as under:-
 - I. Rs.1,23,210/- (DDO, DLSA) (for 11 photocopier machines).
 - II. Rs.4,590/- (DSLSA, Grant in Aid AC) (for 01 photocopier machine).
- 2. The caution money i.e. 25% of reserve price in the form of Bank drafts of any Nationalized Bank in favour of:-
 - I. Rs.30,803/- (DDO, DLSA) (for 11 photocopier machines).
 - II. Rs.1,148/- (DSLSA, Grant in Aid AC) (for 01 photocopier machine).
- 3. Only bidder who deposit the caution money of as mentioned above i.e. 25% of reserve price in the form of Bank drafts of any Nationalized Bank shall be allowed to participate in auction/bid. The caution money of all the unsuccessful bidders will be refunded on the same day of the auction/bid.
- 4. The caution money shall be accepted from 24/02/2020 to 25/03/2020 (between 10 A.M. to 2 P.M.) and on 26/03/2020 (between 10.00 A.M. to 11.00 A.M.) only.
- 5. The successful bidder shall deposit the offered bid amount or atleast 50% amount of bid amount (balance amount after adjustment of caution money deposited) in the form Demand Drafts/Pay orders of any Nationalized Bank in favour of details given above at srl. No.02 within 48 Hrs. after day of auction/bid. The remaining balance if any shall be deposited in Demand Drafts/Pay orders latest by 28/03/2020 upto 3 P.M.
- 6. The successful bidder shall remove the auctioned articles after depositing the full payment from abovementioned places/locations on two days after deposition of whole amount of bid or latest by 28/03/2020 upto 4 P.M. of auction/bid failing which the caution money shall be forfeited. On failure to remove the articles within the aforesaid time span, ground rent @ 5% of the bid amount shall be charged for each day or part of the day till removal of the articles from the aforesaid place. If the ground rent so charged, exceeds the sale price deposit, then the bidder shall cease to have any right on the articles and the amount deposited by him shall be adjusted towards ground rent.

7. GST as admissible shall be paid on the bidding cost by the successful bidder.
