- The Auction/bid is proposed on 13/12/2017 at 2:30 P.M. on " "as is where is basis"

- (3) The minimum reserve price for the articles is Rs. 1,05,970/- (Rs. One lac five thousand nine hundred and seventy only ).
- (4) Only bidder who deposit the caution money of Rs. 26,492/- (Rs. Twenty six thousand four hundred and ninety two only) i.e. 25% of reserve price in the form of Bank draft of any Nationalized Bank in favour of "DDO, Delhi State Legal Services Authority', shall be allowed to participate in auction/bid. The caution money of all the unsuccessful bidders will be refunded on the same day of the auction/bid.
