

THE AUCTION WILL BE GOVERNED BY THE FOLLOWING TERMS AND - CONDITIONS:


- (1) The minimum reserve price for Mahindra Scorpio is Rs. 42000/- (Rs. Forty two thousand only).
- (2) Only bidder who deposit the caution money of Rs. 4200/- for Mahindra Scorpio in the form of Bank draft of any Nationalized Bank in favour of '**DDO, Delhi State Legal Services Authority**', shall be allowed to participate in auction/bid. The caution money of all the unsuccessful bidders will be refunded on the same day of the auction/bid.
- (3) The caution money shall be accepted on 22/02/2018 between 10:00 A.M. to 2:30 P.M. only.
- (4) The successful bidder shall deposit the amount of bid (balance amount after adjustment of caution money deposited) in the form of Bank draft of any Nationalized Bank in favour of '**DDO, Delhi State Legal Services Authority**' on the same day of auction/bid or latest by next working day upto 3:00 P.M.
- (5) The successful bidder shall remove the auctioned vehicles from Karkardooma Court Complex on the same day or latest by next working day upto 5:00 P.M. of auction/bid failing which the caution money shall be forfeited. On failure to remove the vehicle within the aforesaid time span, ground rent @ 1% of the bid amount shall be charged for each day or part of the day till removal of the vehicle from the aforesaid place.
