Sealed Tenders/Quotations are invited for disposal of 42 Chairs on "as is where is basis".

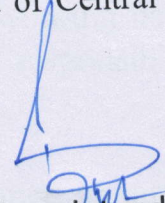
1. Bid is proposed for auction on **22/10/2021 at 1.00 p.m.**
2. Envelope carrying the bid must be superscripted in capital letter with "**OFFER FOR AUCTION SALE OF 42 CHAIRS**". Minimum reserved price (Offset Price) of chairs are **Rs.68,487/- (Rs.Sixty Eight Thousand Four Hundred and Eighty Seven only)**.
3. Intending tenderers are advised to inspect the above mentioned 42 chairs kept in Central Office, Patiala House Court Complex from **17/09/2021 to 21/10/2021 between 11:00 A.M. to 4.00 PM**, on any working day before submitting the tender. Each tender must accompany an 25% earnest money deposit of **Rs.17,122/- (Rs. Seventeen Thousand One Hundred and Twenty Two only)** in shape of Bank Draft of any Nationalized Bank in favour of '**DDO, DLSA**', which will be refunded to the tenderers, whose tenders are not accepted except in case of the successful bidder. Bid price offered shall not be less than the minimum (offset) price as mentioned above.
4. Tender should reach undersigned on or before dated **21/10/2021 upto 3.00 PM** at the latest. Tenders received shall be opened by the Sale Auction Committee in the Central Office, Delhi Legal Services Authority, Patiala House Court, New Delhi on **22/10/2021 at 1.00 p.m.** in the presence of the tenderers or their authorized representatives. If this day is declared later as a Government holiday, then the tenders will be received and opened on the next working day as per the scheduled time. The undersigned will not be held responsible regarding late submission/received of tender in any manner.
5. Highest tenderer, whose tender is accepted shall deposit the balance amount within two days of the deposit of the initial amount. If highest bidder does not accept the offer of sale of vehicle for any reasons whatsoever it may be, and withdraws from the bidding, the EMD deposited by such bidder will be forfeited. Second highest bid amount may be considered for sale, if accepted by the Competent Authority and accordingly the second highest bid amount will be considered as the highest bid amount, subject to minimum reserve price

conditions. If such second highest bidder also does not prefer the sale offer and withdraws from the bidding, after having decided as the highest bidder, the EMD deposited by him/her will also be forfeited to this Authority.

6. Successful bidder shall take permission and remove the 42 chairs from the Authority within two days of deposit of the bid amount. On failure to remove the 42 chairs within the aforesaid time span, ground rent @ 5% of the tendered amount shall be charged for each day or part of the day till removal of the 42 chairs from the aforesaid place. If the ground rent so charged, exceeds the sale price deposit, then the tenderer shall cease to have any right on the chairs and the amount deposited by him shall be adjusted towards ground rent.
7. GST as admissible shall be paid on the bidding cost by the successful bidder.
8. Once the bid/auction is accepted, it cannot be withdrawn and it will be assumed that goods/articles have been accepted by the party on "as is where is basis".
9. All the expenses for loading, unloading and shifting of the goods/articles will be borne by the buyer.
10. Only one person shall be allowed to accompany the bidders.
11. Competent Authority reserves the right to accept or reject any of the bid without assigning any reasons.
