Sealed Tenders/Quotations are invited for disposal of 10 KVA Online UPS and 20 KVA Online UPS on "as is where is basis".

- The Auction/bid is proposed on 23.03.2021 at 2:30 P.M. (1)
- (2) The items lying at Central Office, DSLSA, Patiala House Courts, New Delhi may be available for inspection between 10 A.M. to 2 P.M. on all working days from 18/02/2021 to 22/03/2021. For this purpose Mrs. Rekha Chowdhury, Assistant may be contacted over Tel. no. 23071624. The interested parties may participate for bid/auction on the date, time and venue mentioned above.
- The minimum reserve price for the articles is Rs.1,74,350/- (Rs. One Lac Seventy (3) Four Thousand Three Hundred and Fifty only).
- Only bidder who deposit the caution money of Rs. 43,588- (Rs. Forty Three (4) Thousand Five Hundred and Eighty Eight only).i.e. 25% of reserve price in the form of Pay Order/Demand draft of any Nationalized Bank in favour of "DDO, Delhi State Legal Services Authority', shall be allowed to participate in auction/bid. The caution money of all the unsuccessful bidders will be refunded on the same day of the auction/bid.
- The caution money shall be accepted from 18/02/2021 to 22/03/2021 between (5) 10 A.M. to 2:00 P.M. only.
- The successful bidder shall deposit the offered bid amount or atleast 50% (6) amount of bid amount ((balance amount after adjustment of caution money deposited) in the form of Pay order/ Demand Draft within 24 Hrs. after day of auction/bid. The remaining balance if any shall be deposited through Pay Order/ Demand Draft latest by next working day on 24/03/2021 upto 3 P.M.
- The successful bidder shall remove the auctioned articles after depositing the (7) full payment from Central Office, DSLSA, Patiala House Courts, New Delhi on the same day after deposition of whole amount of bid or latest by next working day on 24/03/2021 upto 4 P.M of auction/bid failing which the caution money shall be forfeited. On failure to remove the articles within the aforesaid time span, ground rent @ 5% of the bid amount shall be charged for each day or part of the day till removal of the articles from the aforesaid place. If the ground rent so charged, exceeds the sale price deposit, then the bidder shall cease to have

- any right on the articles and the amount deposited by him shall be adjusted towards ground rent.
- (8) GST as admissible shall be paid on the bidding cost by the successful bidder.
- (9) Once the bid/auction is accepted, it cannot be withdrawn and it will be assumed that goods/articles have been accepted by the party on "as is where is basis".
- (10) All the expenses for loading, unloading and shifting of the goods/articles will be borne by the buyer.
- (11) The EMD received from unsuccessful bidders will be returned to them without any interest.
- (12) Only one person shall be allowed to accompany the bidder/kabari.
