 - Rs.1,52,193/- (DDO, DLSA) (for 11 photocopier machines).
 - Rs.5,769/- (DSLSA, Grant in Aid AC) (for 01 photocopier machine). I.
- The caution money i.e. 25% of reserve price in the form of Bank drafts of any 2. Nationalized Bank in favour of:-
 - Rs.38,100/- (DDO, DLSA) (for 11 photocopier machines).
 - Rs.1,500/- (DSLSA, Grant in Aid AC) (for 01 photocopier machine).
