

THE AUCTION WILL BE GOVERNED BY THE FOLLOWING TERMS AND CONDITIONS :

- (1) The Auction/bid is proposed on 05/01/2018 at 2:30 P.M. on "as is where is basis"
- (2) The items lying at PLSC, Gole Market, New Delhi may be available for inspection between 10 A.M. to 2 P.M. on all working days from 02/01/2018 to 05/01/2018 (between 10 A.M. to 2 P.M.). For this purpose Sh. Ramesh Kumar Bhatia may be contacted over Tel. no. 23071624. The interested parties may participate for bid/auction on the date, time and venue mentioned above.
- (3) The minimum reserve price for the articles is Rs. 28,500/- (Rs. Twenty eight thousand & five hundred only).
- (4) Only bidder who deposit the caution money of Rs. 7,125/- (Rs. Seven thousand one hundred and twenty five only) i.e. 25% of reserve price in the form of Bank draft of any Nationalized Bank in favour of "DDO, Delhi State Legal Services Authority", shall be allowed to participate in auction/bid. The caution money of all the unsuccessful bidders will be refunded on the same day of the auction/bid.
- (5) The caution money shall be accepted from 02/01/2018 to 05/01/2018 between 10 A.M. to 2:00 P.M. only.

- (6) The successful bidder shall deposit the offered bid amount or atleast 50% amount of bid amount ((balance amount after adjustment of caution money deposited) in the form Demand Draft/Pay order of any Nationalized Bank in favour of **"DDO, Delhi State Legal Services Authority"** within 24 Hrs. after day of auction/bid. The remaining balance if any shall be deposited in Demand Draft/Pay order latest by next working day on 06/01/2018 upto 3 P.M.
- (7) The successful bidder shall remove the auctioned articles after depositing the full payment from Permanent Legal Services Clinic, Shaheed Bhagat Singh Place, Gole Market, New Delhi on the same day after deposition of whole amount of bid or latest by next working day on 06/01/2018 upto 4 P.M of auction/bid failing which the caution money shall be forfeited. On failure to remove the articles within the aforesaid time span, ground rent @ 1% of the bid amount shall be charged for each day or part of the day till removal of the articles from the aforesaid place. If the ground rent so charged, exceeds the safe price deposit, then the bidder shall cease to have any right on the articles and the amount deposited by him shall be adjusted towards ground rent.
- (8) GST as admissible shall be paid on the bidding cost by the successful bidder.
- (9) Once the bid/auction is accepted, it cannot be withdrawn and it will be assumed that goods/articles have been accepted by the party on **"as is where is basis"**.


