NOTIFICATION

This is to inform that Delhi State Legal Services Authority (DSLSA) as per instructions of National Legal Services Authority (NALSA) will organize Special Lok Adalats for disposal of cases **under Section 138 of the Negotiable Instruments Act, 1881**, primarily relating to cheque dishonour cases, on **18.07.2026 and 21.11.2026** in Delhi District Courts and High Court of Delhi, New Delhi.

These Special Lok Adalats shall be organized for amicable settlement of NI Act cases, including both pending cases as well as pre-litigation matters, with a view to reducing pendency and facilitating expeditious and meaningful resolution of disputes.

Litigants/parties may move an application for listing of their cases in the said Special Lok Adalats before the concerned Courts, where their cases are pending, at the earliest. In case of pre-litigation matters, the parties may approach the office of the undersigned so that appropriate steps may be taken well in time for their settlement through the Special Lok Adalats.

The concerned judicial officers/DLSAs are requested to undertake advance identification and listing of eligible cases so that notices may be issued to the parties in time and their presence may be secured for effective settlement. An adequate number of benches may be constituted, and active assistance of trained mediators as Associate Members may also be ensured so as to facilitate meaningful and expeditious settlements. Concerted efforts may be made to maximize disposal of matters during the said Special Lok Adalats.
