NOTIFICATION

This is to inform that in view of Notification No.86/G-4/Genl.-I/DHC dated 08.09.2026 issued by the Ld. Registrar General, High Court of Delhi, New Delhi whereby Second Saturday, the 10th October 2026 has been declared as a Court sitting day for the Courts subordinate to the High Court of Delhi, **Hon'ble Patron-in Chief, DSLSA**, has been pleased to postpone the upcoming **National Lok Adalat** to be held on **10.10.2026 to 25.10.2026 (Sunday)** in all Delhi District Court Complexes, namely Tis Hazari, Karkardooma, Patiala House, Rohini, Saket, Dwarka, and Rouse Avenue Courts Complexes, for amicable settlement of all types of civil and criminal compoundable cases except divorce cases.

Apart from the above District Court Complexes, the National Lok Adalat shall also be organized on the aforesaid date, i.e. **25.10.2026 (Sunday)**, at the High Court of Delhi, Debt Recovery Tribunals (DRTs), Permanent Lok Adalats, the Delhi State Consumer Disputes Redressal Commission, and the District Consumer Disputes Redressal Commissions.

All concerned Courts/Forums/Tribunals/stakeholders are requested to inform the litigants/parties accordingly.

Litigants/parties may move an application for listing their cases in the National Lok Adalat before the concerned Court(s)/Forum(s)/Tribunal(s) where the case is pending, at the earliest. In case of pre-litigative matters, litigants/parties may move an application before the office of the undersigned, latest by seven days prior to the date of National Lok Adalat.

As far as Traffic challans pending on Virtual Court portal are concerned, it is informed that the compoundable challans pending till 30.06.2026 will be taken up and litigants/violators can download the challan Slip(s) directly through the Link (<https://traffic.delhipolice.gov.in/lokadalat>) from 19.10.2026 at 10 a.m. onwards, subject to a maximum limit of 50,000 challans per day, till exhausting the overall limit of 2 lakh challans.
