- Attendance at all training programs and refresher courses organized by DSLSA and the District Legal Services Authorities (DLSAs) is **mandatory**. Any unauthorized absence from these sessions may result in your immediate **removal from the panel**.

5. You must submit detailed, **case-wise progress reports on a monthly basis** to your respective District Legal Services Authority (DLSA) with respect to the assigned cases.
6. The Authority reserves the right to **expand the scope of your duties** to achieve the statutory objectives of the Legal Services Authorities Act, 1987, its Rules, Regulations, and related schemes.

REMOVAL AND PROFESSIONAL MISCONDUCT:

1. You may be removed from the panel if your performance is deemed unsatisfactory, or if you contravene the Legal Services Authorities Act, 1987, its Rules, and Regulations.
2. Charging or soliciting any remuneration, fee, or cash gratification from an aided person will result in immediate removal. Further disciplinary action for professional misconduct will be initiated as per **Regulation 10 (previously Regulation 7) of the Delhi State Legal Services Authority Regulations, 2002.**
