The application can be submitted only by hand or sent through speed post/registered post. Applications send through mail will not be accepted.
2. The application along with all required documents should **positively reach the NSLSA office latest by 2:00 PM, 13/04/2026**. No application shall be accepted after the last date & time.
3. Candidates applying for the post of Driver shall use the application form enclosed as Annexure-I.
4. All the candidates must ensure that application forms are properly filled up and all the necessary documents are enclosed/attached at the time of submission of application. Incomplete/incorrect applications will be rejected.
5. Applicants serving in Government/Organization/Private Sector/Undertaking/Autonomous bodies must send their applications supported with '**No Object Certificate**' and recommendation of the employer.
6. Three (3) years driving experience of the applicants.
7. Selected candidates once engaged as driver, shall not be allowed to engage in any Private Firm/Govt. Organisation/Semi Govt. Organisation or any other thereon.
