R E S O L U T I O N

Government had under consideration the question of increasing the amount of pension granted to the Freedom Fighters by the State Government. After careful consideration, Government is now pleased to direct that the amount of Rs. 50/- p.m. paid to the Freedom Fighters for life time should be increased to Rs. 100/- p.m. with effect from the 1st April, 1975, in respect of those Freedom Fighters who are in receipt of pension of Rs. 50/- p.m. exclusively from the State Government, i.e. the Freedom Fighters who are at present receiving pension of Rs. 50/- p.m. for life time from the State Government only. Freedom Fighters who are in receipt of pension from the State Government and also from the Government of India or only from the Government of India are not eligible for grant of pension at the increased rate of Rs. 100/- p.m. District Collectors should prepare revised estimates on the basis of the increase in the amount of pension to the Freedom Fighters and submit them to Government on or before the 31st August, 1975.

2. The expenditure on account of payment of pension at the revised rate of Rs. 100/- p.m. to the eligible Freedom Fighters should be debited to the Budget Head "229 Social Security and Welfare-E-Other Social Security and Welfare Programme Pension to Freedom Fighters and their dependents etc." and met from the grants sanctioned thereunder during the current financial year i.e. 1975-76.
