

Revised Policy Guidelines for disbursement of Central Samman' Pension to be followed by authorized Public Sector Banks.

The Ministry of Home Affairs has been disbursing pensions to the Freedom Fighters by the name of a Scheme called Central Samman Pension Scheme since 1969. The Scheme essentially is a token of honour by a grateful nation to the honourable freedom fighters and their dependents.

- However, in the last few years, it has come to the Ministry's attention that certain discrepancies have crept in the disbursement of this Scheme by the Public Sector Banks. This led to an Internal Audit conducted by the Ministry. As per the Audit, it was found that certain existing provisions were prove to misuse and misinterpretation. Now, therefore, to abundantly clarify the policy and to avoid the misuse of the scheme, the Government hereby revises the Policy Guidelines (Copy enclosed) for Central Samman Pension to be followed by all concerned, including the banks, while disbursing the pension to the Central Freedom Fighters Pensioners.
