CONSTITUTION OF INDIA.

No. EXM. 1277-XVII.—In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Mahahtra is hereby pleased to make the following rules further to amend the harashtra Government Subordinate Secretariat Service (Superintendents)
Departmental Examination Rules, 1977, namely:—

- 1. (1) These rules may be called the Maharashtra Government Subordinate Secretariat Service (Superintendents) Departmental Examination (Amendment) Rules, 1979.
- (2) Rule 2 of these rules shall come into force from the date of publication of these rules in the Official Gazette and rule 3 shall be deemed to have come into force on the 1st day of November 1977.
- 2. In the Maharashtra Government Subordinate Secretanal Service (Superintendents) Departmental Examination Rules, 1977 (hereinafter referred to as "the principal rules"), for the words "Subordinate Secretariat Service", wherever they occur (including in the preamble), the words "Subordinate Mantralaya Service" shall be substituted.

- 3. In rule 10 of the principal rules,—
 - (1) in clause (a), the word "and" shall be deleted;
- (2) in clause (b), for the words "existing rules." the words "existing rules; and" shall be substituted;
 - (3) after clause (b), the following clause shall be added, namely:—
 "(c) Assistants who have attained the age of forty-five years on the 1st day of November 1977 or attains that age on any date thereafter:

Provided that, the seniority lost by them in accordance with the provisions of rule 5, shall not be restored to them on account of such exemption."
