Sir,  
I am directed to refer to this Ministry's letter of even number dated 16<sup>th</sup>/19<sup>th</sup> August, 2002 on the above subject and to inform you that it has now been decided to grant central pension to the participants of 2<sup>nd</sup> Phase of Goa Liberation Movement (1954-55), who have been granted freedom fighters pension by the State Government by 1<sup>st</sup> August, 2002, by relaxing the eligibility criteria under the Swatantrata Sainik Samman Pension Scheme, 1980.

2. With a view to enable this Ministry to grant Samman Pension to the freedom fighters of Goa Liberation Movement Phase-II, a simple application form has been devised and is enclosed herewith. It is requested that the application forms may be handed over to the eligible persons urgently and they may be asked to furnish the same to the designated authorities of the State Govt. as soon as possible, supported by an affidavit, a format of which is also enclosed. On receipt of the application forms from the persons concerned, the State Govt. may kindly verify and append their verification report on the application form itself in Part II and forward the same to the undersigned for urgent action on their cases. We would highly appreciate if urgent action is taken and application forms duly completed and verified by the State Government are sent to us within a month or so.

3. It may kindly be noted that the application form is to be supported by only two documents viz: (i) an affidavit as per enclosed proforma and (ii) an attested copy of the PPO concerning State pension.

4. It may kindly be ensured that verification report of the State Govt. in Part III is appended on Page 2 of the application form itself and not attached in a separate sheet. Further, the sanction No. and Date regarding State pension should invariably be filled in Part III and duly signed by the authorised officer of the State Government.
