Grant of Swatantrata Sainik Samman Pension to the participants of Goa Liberation Movement, Phase-II (1954-55) under the Swatantrata Sainik

Samman Pension Scheme, 1980.

I am directed to refer to letter No. POS -2006/310/C.R.59/FFC-1 dated 25.7.2006 and to Sir, say that going through the Identification documents submitted by Smt. Champabai (1st wife of Shri Baburao Vishvnath Dhavle) it was learnt that late freedom fighter has two wives. The 2nd wife i.e. Smt. Leelabai Baburao has not submitted Identification documents for grant of pension in her name. She has submitted only a photographs with the Ids of 1st wife. It is requested to you to furnish the following documents from Smt. Leelabai after scrutinizing thoroughly each of them: -

- Four attested Joint photographs of the applicant, his/her spouse and unmarried /Unemployed daughter if any, pasted on four plain papers, with attestation on the photo (face) itself. (a)
- Four slips giving name and age of the spouse and unmarried/unemployed daughter, if any: (b)
- Four slips having three specimen signatures each (in four original slips). (c)
- Four slips showing thumb and four finger impressions of both hands (in four original slips). (d)
- Four slips indicating marks of identification (mark on face/body). (¢)
- Four Affidavit in original on non-judicial stamp paper sworn before the Executive Magistrate giving details of applicant's status as a genuine (widow of) freedom fighter, residential address, **(f)** age, date of birth, educational qualifications and occupation, if any. It may also be clearly stated that he/ she, his/her spouse is not already drawing freedom fighter pension from Central Revenues.
- Four slips indicating name and Branch and address of the Public Sector Bank authorized to disburse Central freedom fighter pension where the applicant would like to draw his/her pension (g) and the details of the bank account together with photocopy of the Bank Pass Book. The bank account should be a single account in the name of the person to draw the pension and not a joint account. The following Public Sector Nationalised Banks are authorized in Maharashtra to disburse the freedom fighter pension. The applicant may be advised to opt any one bank from the following:-

- (h) Four copies of death certificate of the late freedom fighter and an affidavit that she has since not remarried (applicable in case the applicant is widow of late freedom fighter).
- (i) Certified copy of State Pension order payment order issued to Smt. Leelabai bearing her pho may also be furnished.
- 2. All the above documents should be attested by the District Magistrate or any Subordivate Officer, not below the rank of a Tehsildar. The stamp should clearly indicate the Name rank /designation and Department/Office of the officer concerned.
- 3. The State Government is requested to scrutinize each of the above-mentioned documents thoroughly before forwarding them to this Ministry. It may be ensured that all the Identification documents listed in Para 1 above bear the identical spelling to rule out the possibility of rejection at any stage. A line, accordingly, to this effect that these documents have been scrutinized and found authentic by the State Government may invariably be included in State Government's letter while forwarding the above documents to this Ministry.
