Executive Summary

This is the 13th edition of Mantralaya Monthly Reforms Report.

E-Office Usage: The **Urban Development Department** leads with **435 e-files**, followed by the **Home Department** with **390 e-files**. The **Medical Education and Drugs Department** produced **361 e-files**, while the **Higher and Technical Education Department** developed **313 e-files**, and the **General Administration Department** processed **256 e-files**, showcasing their strong digital integration and efficiency. However, several departments significantly underperformed, including the **Directorate of Other Backward Bahujan Welfare Department**, **Employment and Self-Employment Department**, and **Revenue and Rehabilitation Department**, which reported **zero e-files**. The **Women and Child Development Department** and **Minority Development Department** performed poorly as well, creating only **7** and **11 e-files**, respectively.

Collector offices, **Ratnagiri** set a remarkable benchmark with **8,920 e-files**, followed by **Satara (4,567)**, **Nashik (3,215)**, **Ahmednagar (2,687)**, and **Kolhapur (2,607)**. In contrast, **Chhatrapati Sambhajinagar (8)**, **Pune (47)**, **Beed (48)**, **Sangli (71)** and **Thane (93)** reported significantly lower e-file creation, reflecting underutilization of digital tools.

Zilla Parishads, **Ratnagiri** once again led with **5,243 e-files**, followed by **Gondia** with **2,941 e-files**, **Akola** with **2,442 e-files**, **Sangli** with **2,113 e-files**, and **Latur** with **1,956 e-files**, demonstrating robust digital governance. However, underperformance was noted in **Sindhudurg**, which reported **no e-file activity**, along with **Beed (97)**, **Buldhana (103)**, **Dharashiv (154)**, and **Jalgaon (192)**.

Aaple Sarkar Grievance Redressal: Several departments are experiencing high pendency rates, with over 80% of cases remaining unresolved. The same issue is prevalent in the Collector's office, Zilla Parishad, and Police departments. However, districts like Jalgaon, Yavatmal, Satara, Sangli, Washim, and Gondia have made considerable progress in reducing their pendency rates, within the CPGRAM system. In contrast, regions such as Nanded, Chandrapur, Parbhani, and Nashik continue to experience some of the highest pendency rates in the CPGRAM system.

The report highlights the performance of different departments under e governance initiatives.

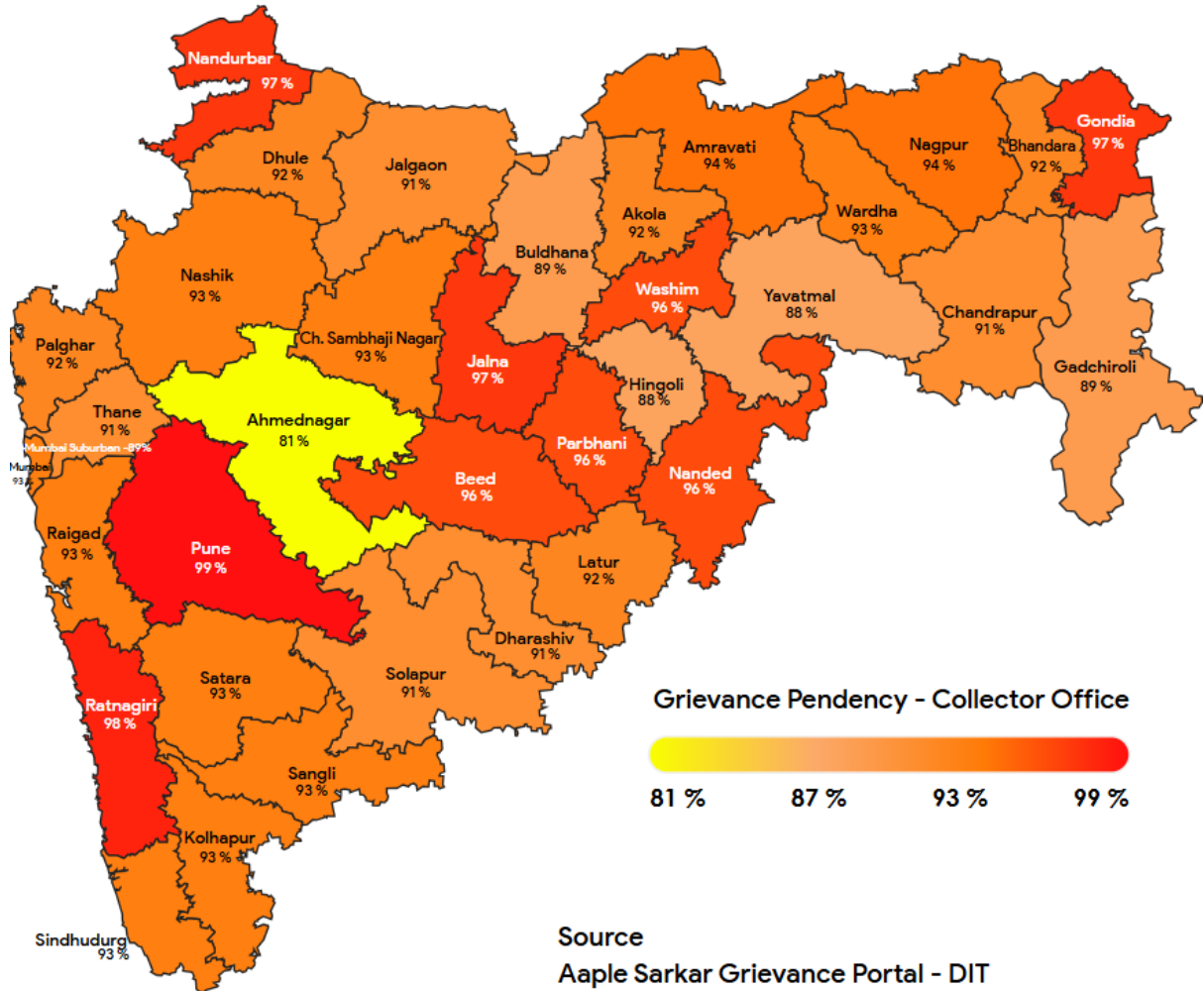

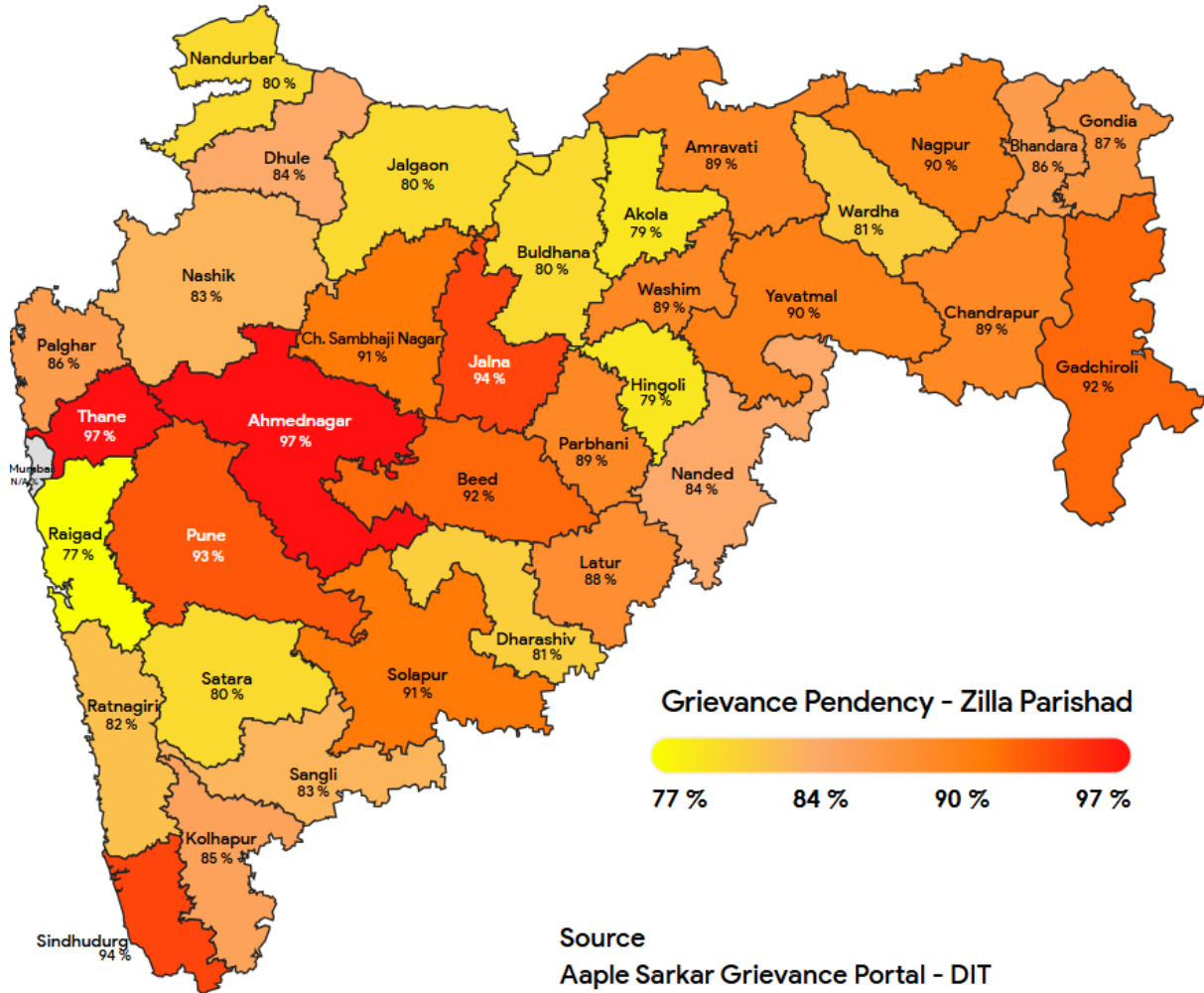


2) Aaple Sarkar Pendency Percentage at Collector Office



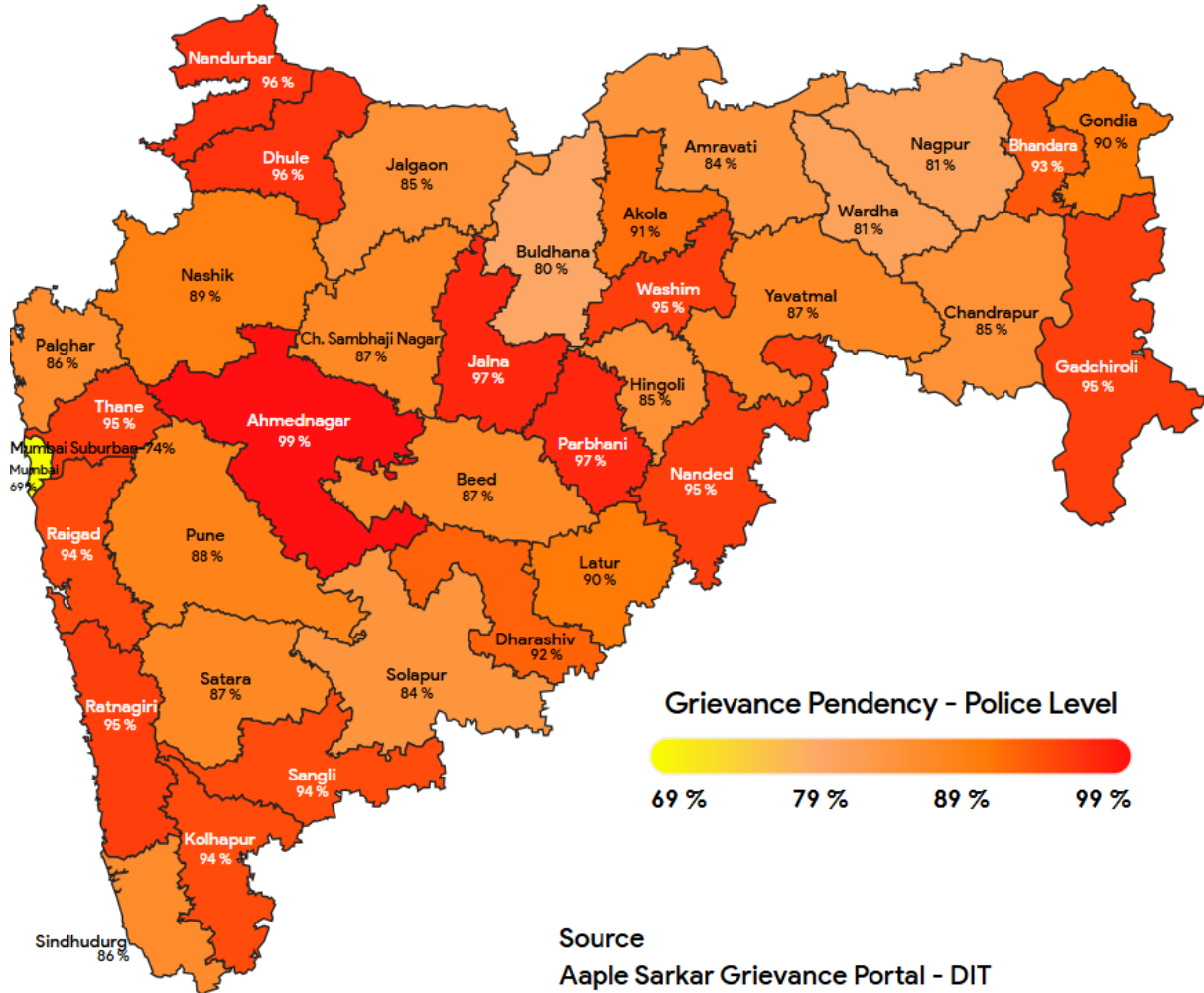


3) Aaple Sarkar Pendency Percentage at Zilla Parishad



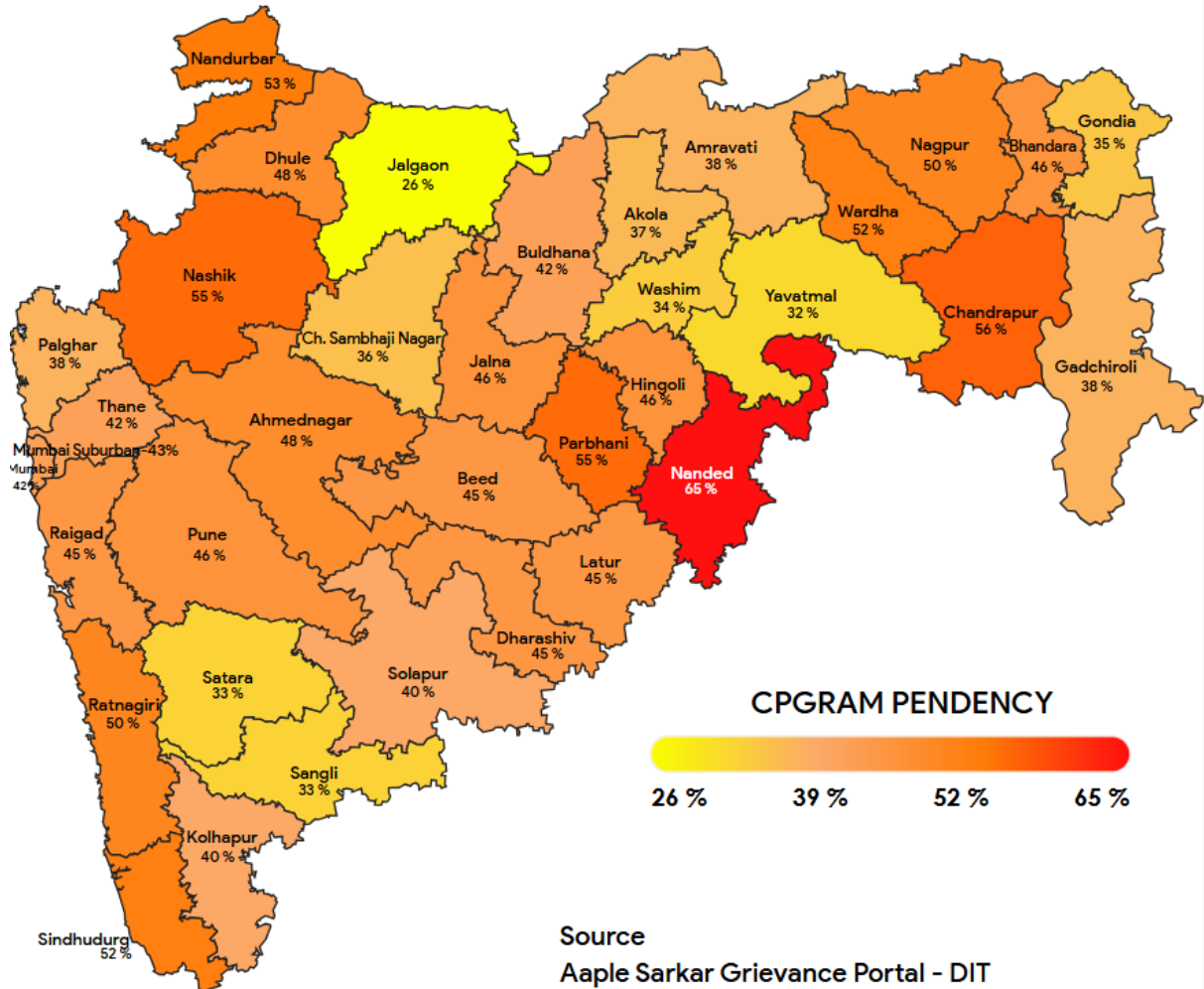


4) Aaple Sarkar Pendency Percentage at Police Level

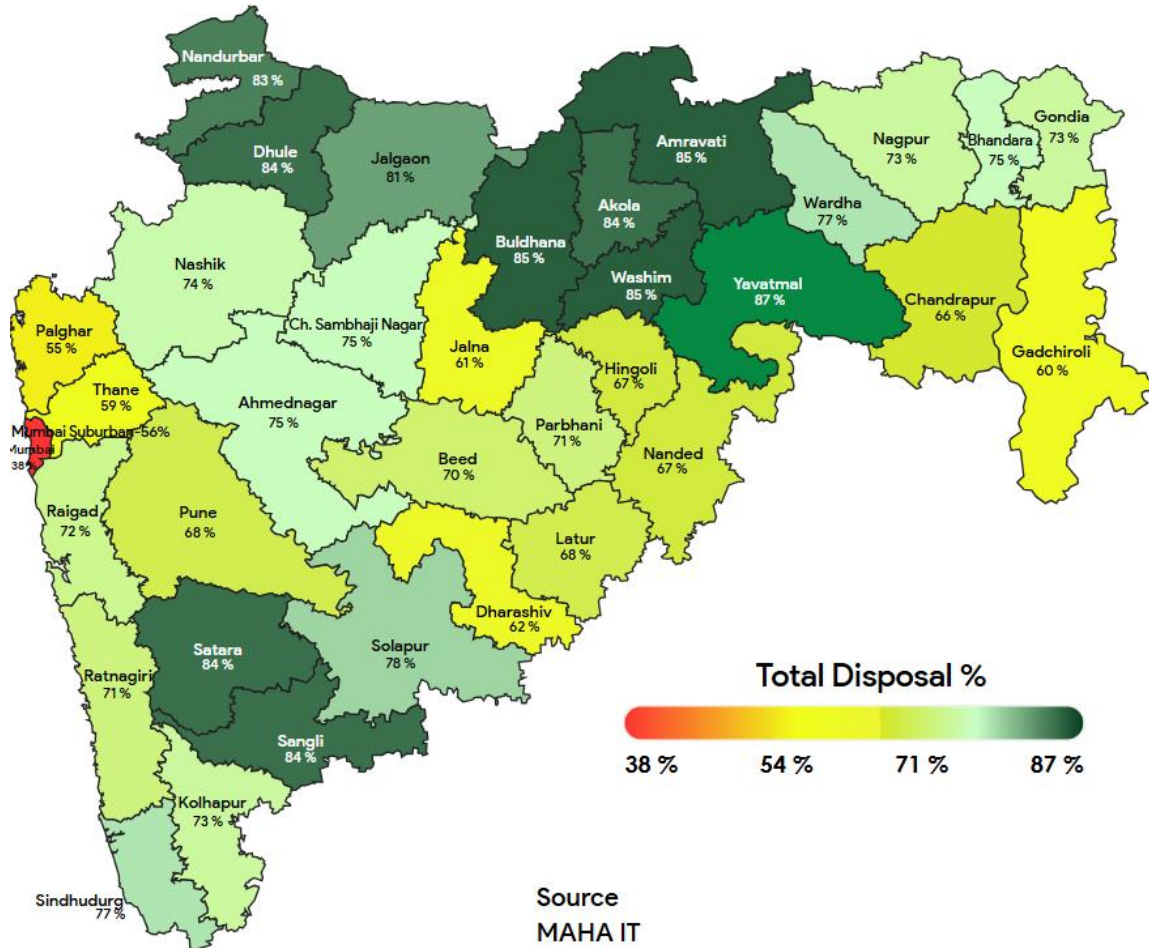
