EXECUTIVE SUMMARY

This is the 16th edition of Mantralaya Monthly Reforms Report.

e-Office Analytics:

In e-Office Analytics, the Rural Development, Agriculture and ADF, and General Administration Departments have demonstrated strong digital adoption with the highest number of e-files created. Among collector offices, Ratnagiri, Latur, and Kolhapur are the top performers. In Zilla Parishads, Akola, Ratnagiri, and Kolhapur have excelled in e-file creation.

Grievance Portal Analytics:

In Grievance Portal Analytics, the Finance-Accounts & Treasury, Finance-Expenditure, and GAD-Reservation Policy Departments have the lowest grievance pendency, ensuring timely redressal, while the Tourism, Home-State Excise Old, and GAD-Freedom Fighter/Ex-Servicemen Welfare Departments have the highest backlog, indicating inefficiencies. Among collector offices, Jalgaon, Chandrapur, and Nashik have managed grievances effectively, whereas Pune, Nagpur, and Nanded face significant delays. Similarly, Jalgaon, Chandrapur, and Hingoli Zilla Parishads have low grievance pendency, while Sindhudurg, Ahmednagar, and Yavatmal struggle with unresolved cases. At the police level, Gadchiroli, Sindhudurg, and Jalgaon have the best grievance resolution, whereas Parbhani, Chhatrapati Sambhaji Nagar, and Bhandara report high backlogs. This highlights the need for streamlined grievance-handling mechanisms in underperforming regions.

Right to Information (RTI) Analytics:

In Right to Information (RTI) Analytics, the Employment Guarantee Scheme, Other Backward Bahujan Welfare, and Parliamentary Affairs Departments have performed well in addressing RTI requests, while the Minorities Development, Co-operative Societies, and Textile Departments report the highest pendency. Among collector offices, Chandrapur, Nagpur, and Nandurbar have low RTI pendency, while Akola, Dhule, and Hingoli struggle with a 100% backlog. In Zilla Parishads, Thane, Ahmednagar, and Dharashiv manage RTI requests efficiently, whereas Akola, Beed, and Bhandara report full pendency. In home police, Jalna, Thane Rural, and Gondia handle RTI requests effectively, while Ahmednagar, Akola, and Amravati face delays. Among municipal corporations, Nanded, Pune, and Chhatrapati Sambhajnagar have lower RTI pendency, whereas Ahmednagar, Chandrapur, and Dhule struggle with 100% unresolved requests. This suggests an urgent need for accountability and improved RTI compliance across poorly performing departments and districts.

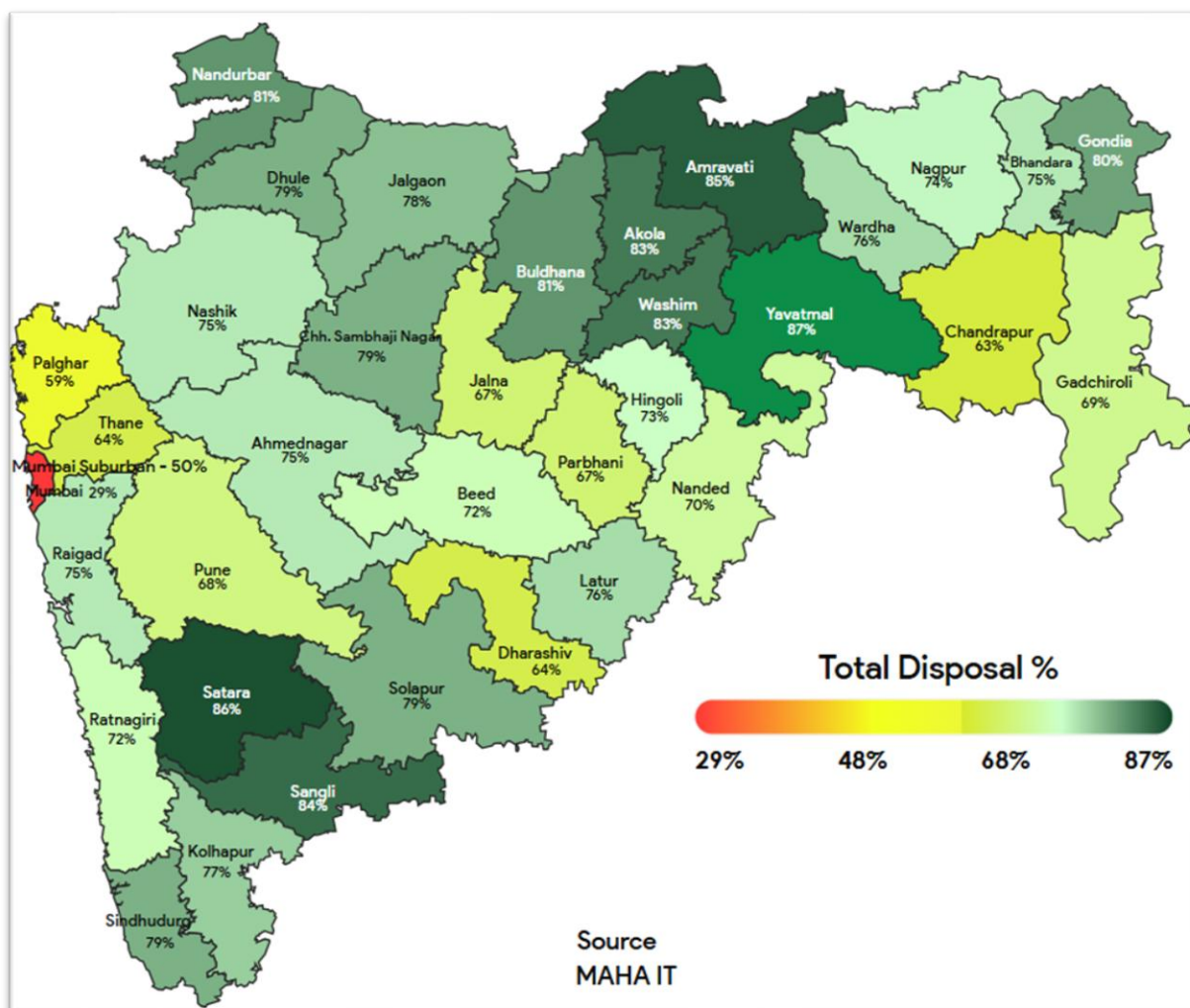
