(18) Vulgar/Obscene/Hurting the sentiments and dignity of women, children, religion, communities/songs, videos will not be allowed in

(19) It shall be ensured by the permit holder that the driver of the vehicle shall follow the directions notified under Motor Vehicle Driving

(20) This permit is subject to the conditions laid down in Section 84 of the Act, and in sub-rule(1) of rule 76 the Bihar Motor Vehicles Rules -

(21) This permit is also subject to condition that:-
