

TERMS AND CONDITIONS


PERMIT NO. BR2026-CC-5199A

VEHICLE NO. BR09PB0504

- 1) This permit is subject to the condition laid down in section 84 of the act.
- 2) That the vehicle shall be used only in a specified area, or on a specified route or routes.
- 3) That the gross vehicle weight on any vehicle used shall not exceed a specified maximum.
- 4) That goods of a specified nature shall not be carried.
- 5) That goods shall be carried at specified rates.
- 6) That specified arrangement shall be made for the housing, maintenance and repair of the vehicle and the storage and safe custody of the goods carried.
- 7) That the holder of the permit shall furnish to the Regional Transport Authority such periodical returns, statistics and other information as the State Government may, from time to time, prescribe.
- 8) That the Regional Transport Authority may, after giving notice of not less than one month -
 - a) Vary the condition of the permit,
 - b) Attach to the permit further conditions,
- 9) That the conditions of the permit shall not be departed from, save with the approval of the Regional Transport Authority.
- 10) That the vehicle shall not be used for carriage of any article, the transport of which is prohibited by or under any law for the time being force in the State of Bihar.
- 11) That the holder of the permit shall cause the permit to be carried in a glazed frame or other suitable container carried in the vehicle in such a way as to maintain it in a clear and legible condition and readily available for inspection at any time by any person duly authorized in that behalf.
- 12) That the holder of the permit shall maintain the vehicle in a clean and sanitary condition.
- 13) That the holder of the permit shall comply with all the requirements of the Act and the rules made there under.
- 14) That the permit and all concerned documents shall always be kept with the vehicle and the driver or other person in charge of a vehicle shall produce the permit, etc. on demand by any officer to the motor vehicle department of and above the rank of an Assistant Inspector of the motor vehicle department of and above the rank of an Assistant Inspector of Motor Vehicles or any Police Officer not below the rank of a Sub-Inspector of Police.
- 15) Any other conditions which may be prescribed.
