- Copy of the Notification of the State Government regarding establishment of Permanent Lok Adalats be provided to the respective Chairman, Permanent Lok Adalat. (Copy enclosed.)
- Drawing and Disbursing Officer (DDO) for the Permanent Lok Adalats are District Judge/Chairman, District Legal Services Authority of respective districts where Permanent Lok Adalats are made functional. (Copy enclosed.)
- 3. All the Chairmen, Permanent Lok Adalats are permitted to engage Class III and Class IV staff on outsourcing basis through Uttarakhand Purv Sainik Kalyan Nigam Ltd. (UPNL) against all the sanctioned posts for the Permanent Lok Adalat.
- 4. All the Chairmen, Permanent Lok Adalats are directed to generate their official e-mail ID immediately; specifically in the name of Permanent Lok Adalat (for example pladehradun@gmail.com or permanentlokadalatdehradun@gmail.com), so that official correspondence may be made through the valid e-mail ID.
- 5. In light of Rule 7(2) of the Permanent Lok Adalat (Other Terms and Conditions of Appointment of Chairman and Other Persons) Rules, 2003, the working days and office hours of the Permanent Lok Adalat shall be the same as that of the Central Government or the State Government, as the case may be. Therefore, the office of Permanent Lok Adalats shall adopt the State Government's calendar and its office hours respectively.
